## **Framework Customer Access Agreement**

This includes: County Councils, Unitary Authorities, City Councils, District and Borough Councils, Town Councils, Universities, Further Education establishments, National Park Authorities, Housing Associations, Police Authorities, Fire and Rescue Services, other Emergency Service organisations, Health Services, Academies, Schools, and the Ministry of Defence.

The Framework Supplier has been selected for their knowledge, technical skill and quality and also their commercial standing and ability to access private and grant funding to support your funding or investment needs. The Framework offers, as a minimum, the following opportunities for you to:

- Collaborate with the supplier to develop feasibility and identify options.
