<b>Awbridge 702</b>	Bridleway	3167 2354 Newtown Road	3188 2353 Danes Road	<u>From Road U.86 to Road C.17</u> From Road U.86, eastwards along 3 ft. wide cinder path through wood on south side of chestnut pale fence then along 4 ft. to 6 ft. wide path enclosed 10 ft. wide between fence and bank to Road C.17 opposite Church Road.
<b>Awbridge 703</b>	Footpath	3239 2352 Church Lane	3266 2392 Lockerley Road	<u>From Road U.86 to Road C.25 at Upper Ratley</u> From Road U.86 northeastwards along 4 ft. wide path enclosed between wire fences, over stile, along cinder path on north side of wire fence, over stile, then along 2 ft. wide cinder path across pasture, over stile, along grass path, and through entrance to Village Hall and grounds to Road C.25.

<b>Awbridge 706</b>	Footpath	3292 2449 Dunbridge Lane	3354 2374 Cooks Lane	<u>From Road B.3084 to Road U.86</u> From Road B.3084 eastwards along 8 ft. wide farm lane, then southeastwards along 12 ft. wide lane, across footbridge, along lane, over stile, across pasture, over stile, and still southeastwards along verge of pasture on west side of hedge, across ditch, over post and rail fence, along path, over post and rail fence, across arable field, over post and rail fence, along 6 ft. wide path through wood, across footbridge, along path, across footbridge, along path, across footbridge, across pasture, over post and rail fence, then southwards along 10 ft. wide lane to Road U.86.

<b>Awbridge 707</b>	Footpath	3332 2361 Cooks Lane	3339 2345 Stanbridge Lane	<u>From Road U.86 to Road B.3084</u> From Road U.86 through field gate, then southwestwards along verge of pasture on north side of hedge, over post and rail fence, then westwards along verge of pasture, over post and rail fence, southwestwards through orchard, over wire fence, and along path enclosed 4 ft. wide between hedges to Road B.3084.	That part of the path which ran between 3341 2347 and 3357 2356 has been diverted and now runs between 3341 2347 and 3332 2361. 1.8 metres wide between 3341 2347 and 3332 2361. Stile at 3333 2357

<b>Awbridge 709</b>	Footpath	3341 2342 Stanbridge Lane	3318 2325 Footpath 501	<u>From Road B.3084 to No.48</u> From Road B.3084 southwards along 8 ft. wide lane, then southwestwards along lane, passing No.13, to No.48.	
<b>Awbridge 710</b>	Footpath	3332 2336 Footpath 709	3342 2321 Romsey Extra 2 at Parish Boundary	1.8 metres wide	
<b>Awbridge 711</b>	Footpath	3270 2311 Coombe Lane	3275 2306 Footpath 502	<u>From Road U.86, at Lower Ratley, to No.48</u> From Road U.86 at Lower Ratley, southeastwards over iron rail fence, along path through spinney, across No.12, then, then along path to No.48.	
<b>Awbridge 712</b>	Bridleway	3185 2287 Danes Road	3278 2316 Coombe Lane	<u>From Road C.17 to Road U.86</u> From Road C.17, through gateway, then eastwards along 8 ft. wide gravelled lane, through field gate, along track through wood south of farm buildings, then along track and path, through gateway, along path widening to 8 ft. wide track, crossing No.11, then northwards across marsh and through iron field gate to Road U.86.	
<b>Awbridge 713</b>	Footpath	3331 2335 Footpath 709	3304 2343 Coombe Lane	<u>From junction with No.9 to Road U.86</u> From junction with No.9, northwestwards across arable field over wire fence, across pasture, across arable field and pasture, over wire fence, through woodland, over stile, and along path to Road U.86.

<b>Awbridge 743</b>	Bridleway	3164 2304 Sherfield English 43 at Parish Boundary	3180 2299 Danes Road	<u>From Road C.17 to Road U.86</u> From Road C.17, westwards and northwestwards along gravelled track enclosed 12 ft. wide between hedges, along track enclosed 25 ft. wide (approx.) between hedges and banks, along track through wood through 8 ft. wide gap in bank, northwestwards and westwards along verge of arable field on northeast side of wood, along 8 ft. wide track on north side of wood, along track between pits and along gravelled track enclosed 10 ft. wide between hedges to Road U.86 north of North Common Farm.
