Bullington 3	Footpath	4555 4121 Road C55	4596 4151 Bullington Manor Lane (U54)	<p><u>From Road C.55 (at Bullington) to Road U.54</u></p> <p>From Road C.55, through angled barrier, northeastwards across pasture, over stile, along grass path approximately 4 ft. wide across marshland, across plank footbridge, along path across marshland, across timber footbridge with single handrail northeastwards and then eastwards along path through Chimple Row, over concrete stile, along path up steep embankment with single handrail support, and crossing railway line, along path down embankment with single handrail support, over concrete stile, northeastwards across pasture, and over stile to Road U.54.</p>
