### **Access and Fairness Regulation Changes – Employer information session**

Hampshire Pension Services will provide an overview of the recent LGPS regulation changes introduced on 1 April 2026.

During this session we aim to cover:

- Changes to unpaid authorised leave
- Changes to child related leave
- When to use actual pensionable pay, assumed pensionable pay (APP) and/or Lost Pensionable Pay

- How APP and LPP should be calculated
- Qualifying Additional Pension Arrangement (QAPA)
- Optional discretions which Employers can add to their discretions policy
- Actions employers may need to take
