## Information about this secure children's home

This secure children's home is managed by a local authority. It is approved by the Department for Education to restrict children's liberty.

The home can accommodate up to 10 children who are aged between 10 and 17. At the time of the inspection, six children were living in the home.

The home cares for children placed by local authorities under section 25 of the Children Act 1989. Admission of any child under section 25 of the Children Act 1989 who is under 13 years of age requires the approval of the Secretary of State.

The commissioning of health services in this home is the statutory responsibility of NHS England under the Health and Social Care Act 2012. Education is provided on site.

The manager of the home has been registered with Ofsted since March 2022.

## Information about this inspection

At this inspection, the inspectors evaluated:

- the care of children
- the safety of children
- the effectiveness of leaders and managers.

Inspectors have looked closely at the experiences and progress of children, using the social care common inspection framework. This assurance inspection was carried out under the Care Standards Act 2000 to assess the effectiveness of the service, how it meets the core functions of the service as set out in legislation, and to consider how well it complies with The Children's Homes (England) Regulations 2015 and the 'Guide to the Children's Homes Regulations, including the quality standards'.

## Findings from the inspection

We did not identify any serious or widespread concerns in relation to the care or protection of children at this assurance inspection.

Children say that they have positive, supportive relationships with staff. They can all identify a trusted adult who they would talk to if they had worries or concerns. Staff are empathic in their approach. They engage warmly with children and help to allay any fears that they may have.

Staff take a risk-informed and child-centred approach when considering their responses to complaints made by children. Complaints made by external parties are also well managed. There is effective managerial oversight that helps to ensure that responses are timely, considerate and clear. When complaints are upheld, apologies are offered, and actions are taken to help ensure that errors in practice are not repeated.

When children make allegations about staff, leaders and managers respond effectively to make sure that children are kept safe. All known information is shared with appropriate agencies in accordance with statutory guidance, and a thorough investigation takes place. This ensures that only staff who are safe to do so work in the home and children are protected from harm.

Staff make the most of the facilities available in order to provide activities for children that are in with their interests, for example barbering and bicycle maintenance. At the time of the inspection, there was excitement about an upcoming pantomime. This was a collaborative effort between children and staff, and an opportunity to collectively celebrate.

Use of physical restraint is frequent. However, records demonstrate that restraint is always used as a last resort and there is good management oversight. The members of the health and well-being team ensure that they speak with the staff and children involved in any incident that results in physical restraint so as to ensure their physical and emotional well-being.

Where children have specific support needs, expert advice and input is sought appropriately to develop plans that give clear guidance for staff to follow and keep children safe and protected from harm. Children make good progress while living in the home, which helps to prepare them for leaving the home.

The recommendation in relation to children's education and learning made at the full inspection in April 2024 will be considered at the next full inspection.
