

**Consultation on the proposal to increase the capacity of  
Bedenham Primary School, resourced provision for pupils  
with social, emotional and mental health needs (SEMH),  
Gosport**

Hampshire County Council would like to hear your views on the proposal to increase the capacity of the resourced provision at Bedenham Primary School, Gosport.

We are running a consultation from 22 March to 30 April 2021.

***Why do you need to enlarge the school?***

Hampshire County Council is committed to expanding successful provision where possible to meet demand. Currently there is an increased need to provide support for pupils with learning difficulties in this area of the county. This proposal will provide much needed specialist educational capacity to meet this increased demand.

There is already an 8 place resourced provision at the school supporting pupils with SEMH needs. The school is successfully meeting the needs of these children in a supportive, safe and secure environment and has an excellent well being and mental health aware environment for all children attending.

With the agreement of Mrs Bolton, the Executive Headteacher, Mrs Wood, the Headteacher and the school Governors, the County Council is proposing to refurbish an area of the school and outdoor space to create a new area in the school for the resourced provision. These works will allow the school to increase the capacity of the resourced provision by an additional 4 places from September 2021. This will give a final overall capacity of 12 within the resourced provision.

***What building works will be taking place?***

Hampshire County Council is proposing to refurbish an area of the school and outdoor space to create a new area in the school for the resourced provision. These works will allow the school to increase the capacity of the resourced provision by an additional 4 places from September 2021.

It is planned that the building works will be completed in the Summer holidays and be completed by September 2021.

***When will the building works start and how will you ensure the health and safety of pupils attending the school whilst the works are taking place?***

The building works will be completed on site in the summer holidays 2021. We will provide the school with further details as the design work for the project progresses so the school can keep you informed of progress and inform you of key dates.

Health and safety of children, staff and visitors is paramount. The County Council works with construction partners who have significant experience of working on school sites. A detailed health and safety plan will be drawn up with the school to include items such as restricting delivery times for materials to avoid the beginning and end of the school day, maintaining safe access routes for pupils, staff and visitors etc.

The construction site will be isolated and will be kept secure from the current school and community users during construction.

***What will be the impact on pupils within the school?***

Bedenham Primary School will be closed to pupils whilst the works are completed. The County Council is liaising fully with the Headteacher and governors on the project to ensure that the implementation of the building works run as smoothly as possible.

***What about the impact on traffic due to the school taking more pupils?***

The school will work closely with the County Council's Travel Planning team to manage the additional traffic relating to the few extra pupils attending the site.

***Will the school receive additional funding due to the numbers increasing?***

Bedenham Primary School will receive additional funding based upon the increase in number of pupils on their roll. This will provide appropriate funding for all additional staffing and resources required for the extra places.

***Will the school have to contribute to the capital build costs?***

No, Hampshire County Council will fund all capital costs for the new spaces, including all teaching accommodation, furniture & IT equipment, landscaping and external works.

***What happens after this consultation?***

The purpose of this consultation is to seek the view of all stakeholders on the principle of increasing the school capacity to meet the demand for additional special school places in the Gosport area.

The consultation and decision-making process is outlined below:

- This initial consultation will run from the 22 March to 30 April 2021.
- A report outlining the consultation responses received will then be taken to the Elected Member for Children's Services & Young People in

May 2021 to decide if the proposal should continue to the formal statutory consultation stage.

- If approved, a statutory Public Notice would be published in May/June 2021 setting out Hampshire County Council's intent to increase the capacity of the school and to add to its designation. This is a four week period in which any representations can be made to the local authority. A final report would then be taken to Elected Member for Children's Services Decision Day in July 2021 who will decide whether or not to proceed with the proposal.

***Will I have the opportunity to discuss the proposal and ask questions?***
