I William Robert Coles of Western Court Farm, Bishops Sutton, Alresford, Hampshire, SO24 0AA, DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since January 1975 the owner of the land known as part of Western Court Farm, Bishops Sutton, Alresford, Hampshire, SO24 0AA, more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the 26<sup>th</sup> day of January 2005 I deposited with Hampshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that the way coloured brown on the said plan and on the plan accompanying this declaration had been dedicated as a road used as a public footpath and the way coloured blue on the said plan and on the plan accompanying this declaration had been dedicated as a footpath. No other ways had been dedicated as highways over my property.

No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated Jan 26, 2005 referred to in 2. above other than the road used as a public footpath and the footpath marked in the appropriate colours on the plan accompanying this declaration and at the present time I have no intention of dedicating any more public rights of way over my property.

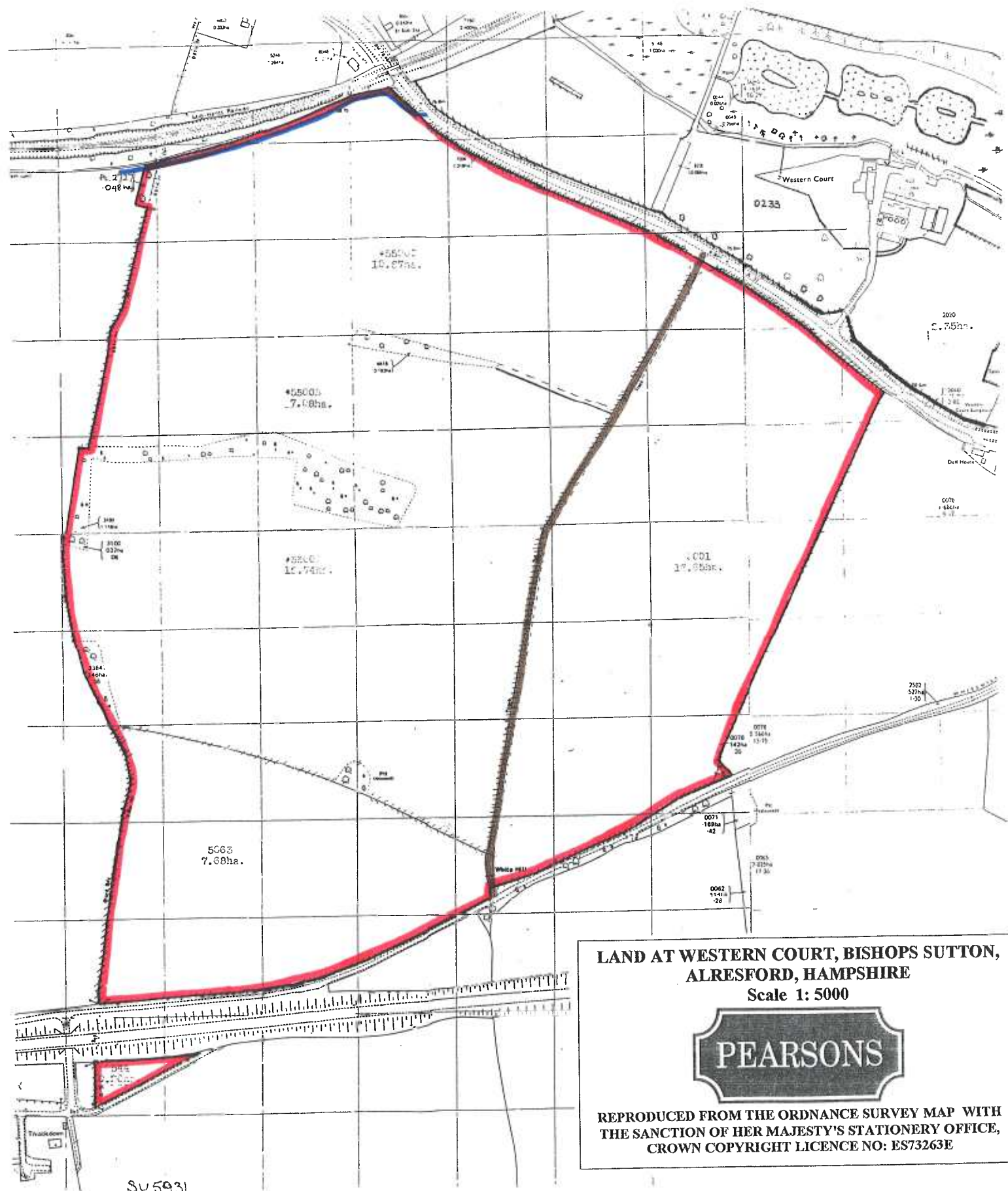
