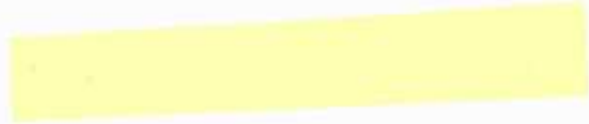
1. I am co-owner of the land coloured blue on the plan accompanying this declaration ("the Land").

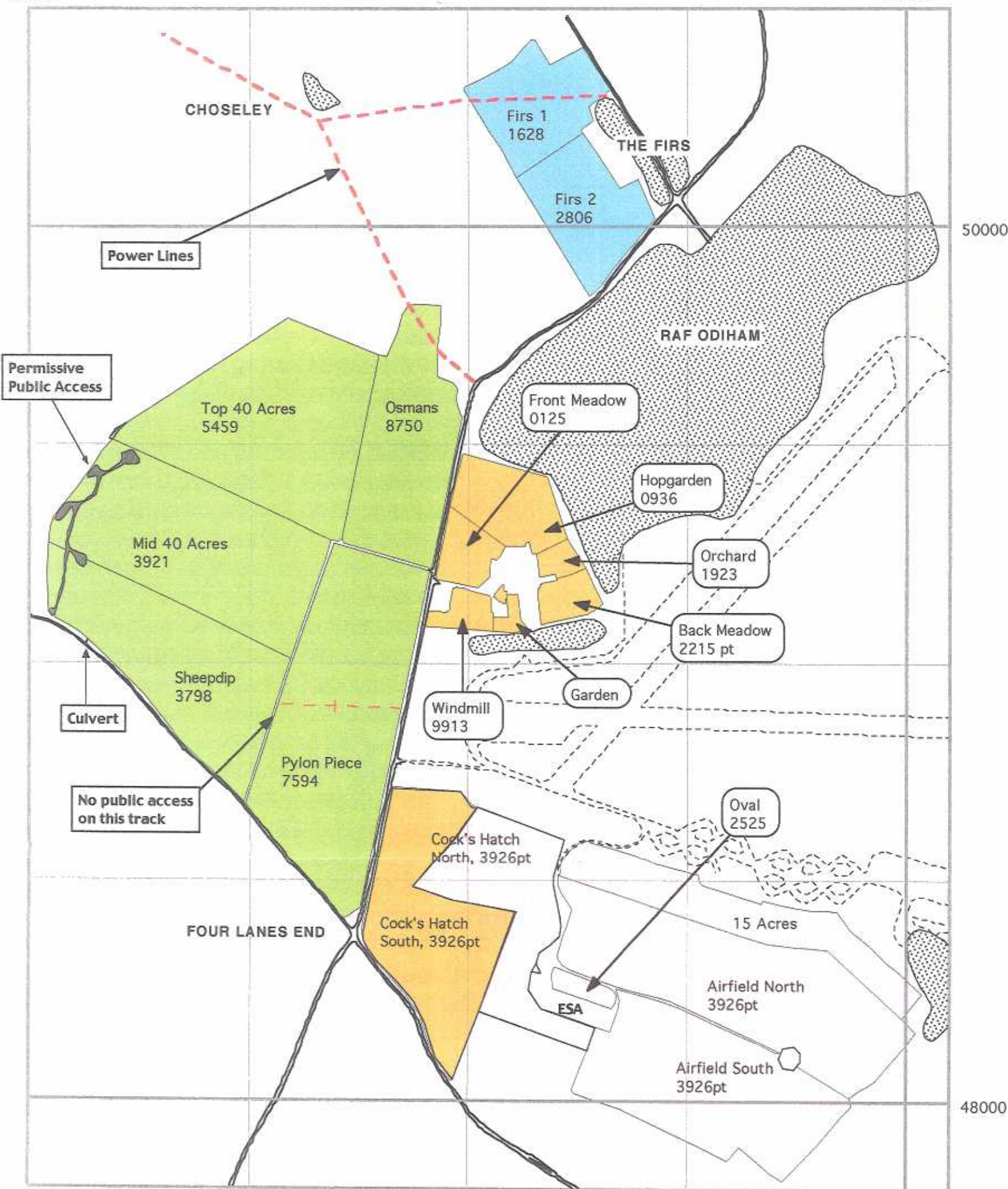
