HIGHWAYS ACT, 1980 - SECTION 31(6) THE WOODLAND TRUST

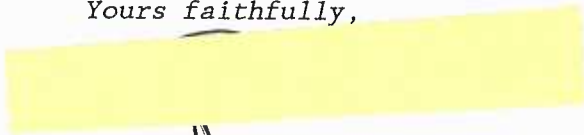
Thank you for your letter of 16th July.



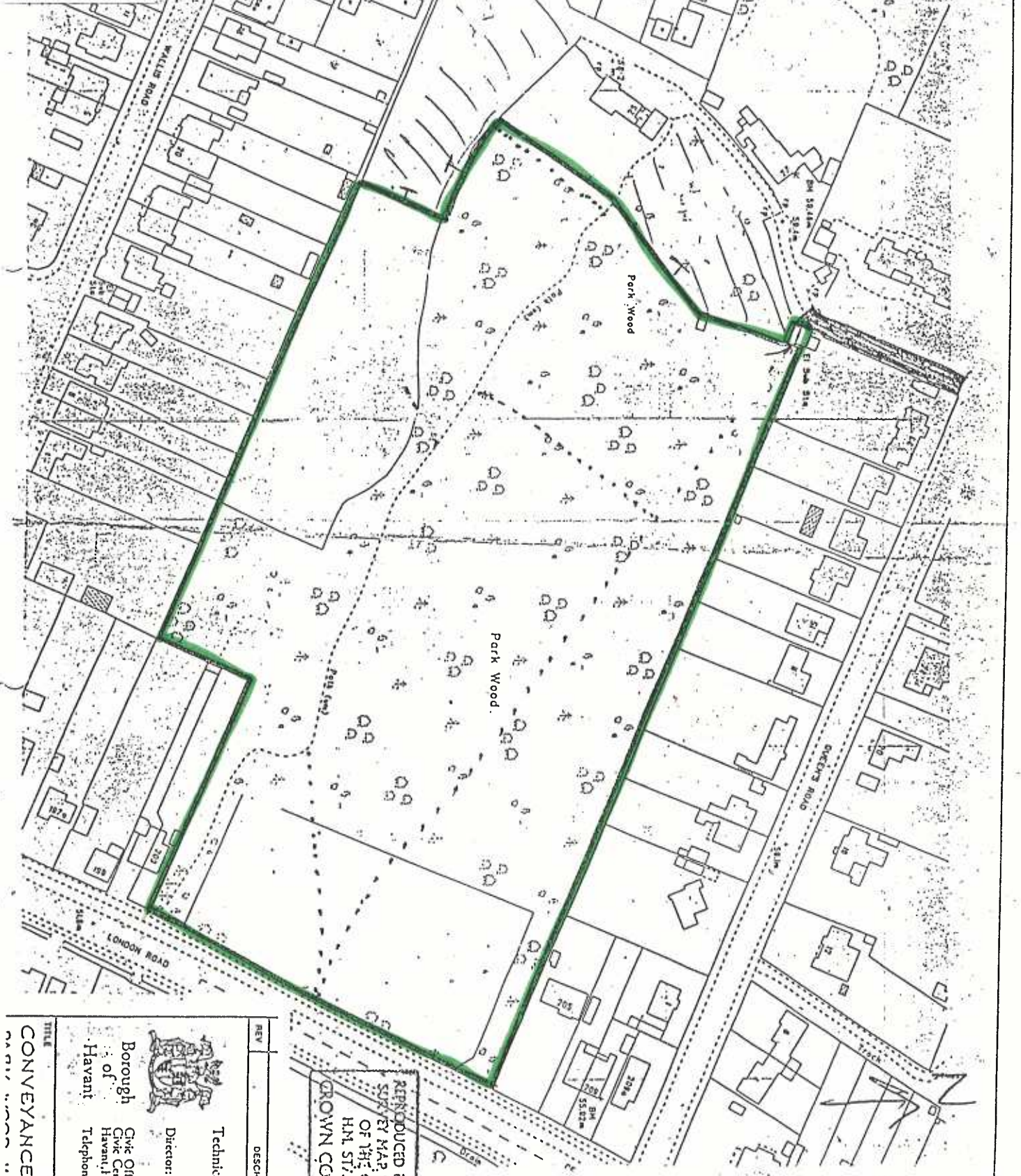
Dear Sir,
