Statutory Declaration

Section 31 (6), Highways Act 1980

I Mr. J. G. Venn DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since 1st October, 2010 the owner of the land known as Stocks Down Farm, Meonstoke, more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the 2nd day of December, 2010. I Mr J. G. Venn deposited with Hampshire County Council, being the appropriate Council, a statement accompanied by a plan delineated my property by red edging which stated that (the ways coloured green on the said plan and on the plan accompanying this declaration had been dedicated as bridleways) (the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as footpaths) (no other ways had been declared as highways over my property).
3. On the 2nd day of December 2010. I Mr. J. G. Venn deposited with Hampshire County Council, being the appropriate Council, a statutory declaration dated 2nd December 2010 stating that no additional ways (other than those marked in the appropriate colour on the plan accompanying this declaration) had been dedicated as (highways with vehicular status) (bridleways) (footpaths) since the deposit of the statement referred to in 2. 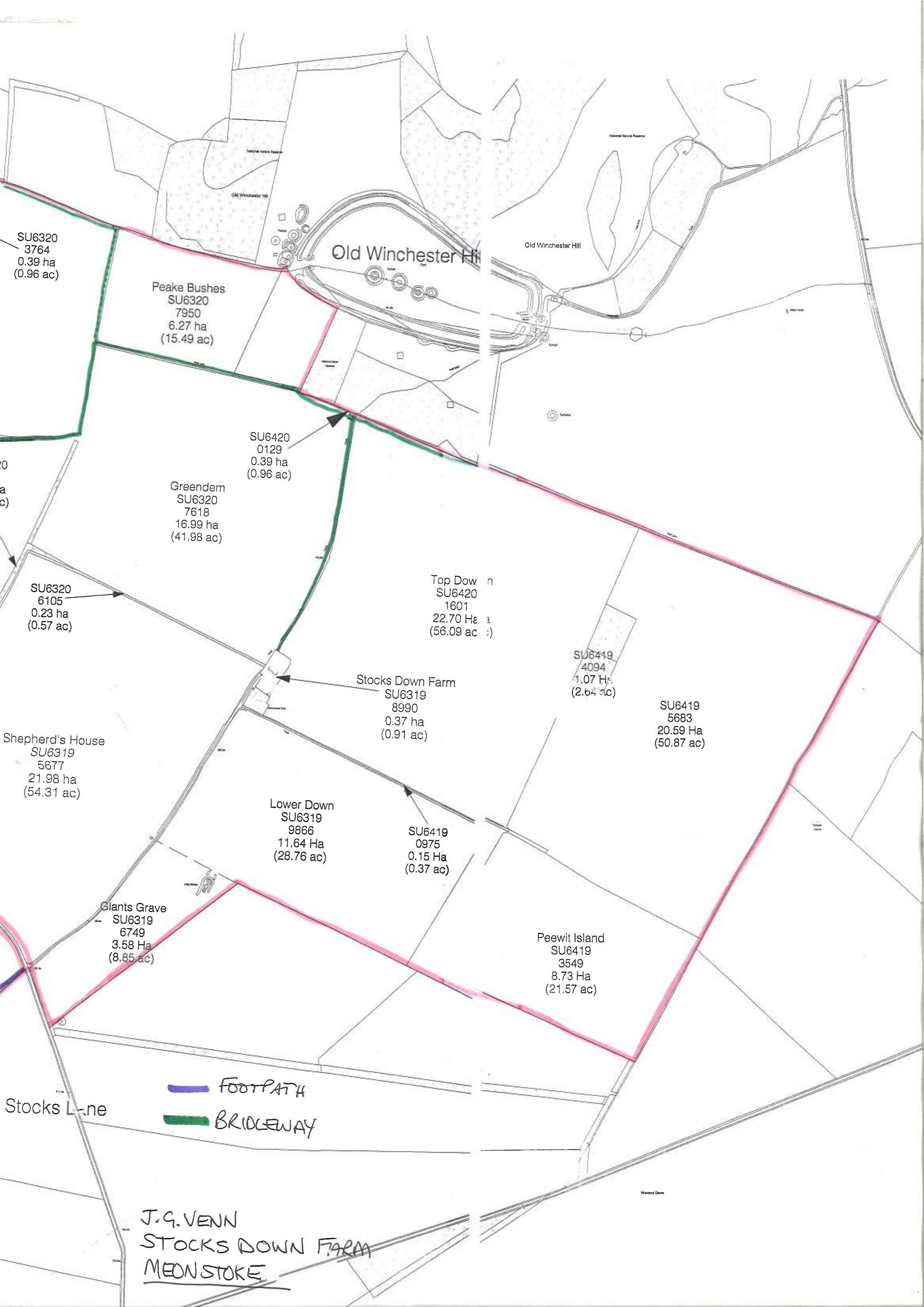
