

STATUTORY DECLARATION

SECTION 31(6) OF THE HIGHWAYS ACT 1980

I ROGER HOPES of Railway Paths Limited whose registered office is situated at 2 Cathedral Square, College Green, Bristol, BS1 5DD, DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I have been employed by Railway Paths Limited as a Surveyor since 2005. I am familiar with the land which is the subject matter of this declaration.
2. Railway Paths Limited has been since 25th January 2001 the owner of the land known as Land near Kimbridge Junction, Hampshire more particularly delineated on the map now produced to me and marked "RH 1" and thereon edged red ("the Land").
3. I am authorised by the Board of Railway Paths Limited to make this declaration, on behalf of the company.
4. On the 22nd March 2011, I Roger Hopes deposited with Hampshire County Council, being the appropriate Council, a statement accompanied by a map delineating Railway Paths Limited's property by red edging which stated that no ways have been dedicated as public right of ways over Railway Paths Limited's property.
5. No additional ways have been dedicated over the Land since the statement referred to in paragraph 4 above and at the present time Railway Paths Limited have no intention of dedicating any more public rights of way over the Land.

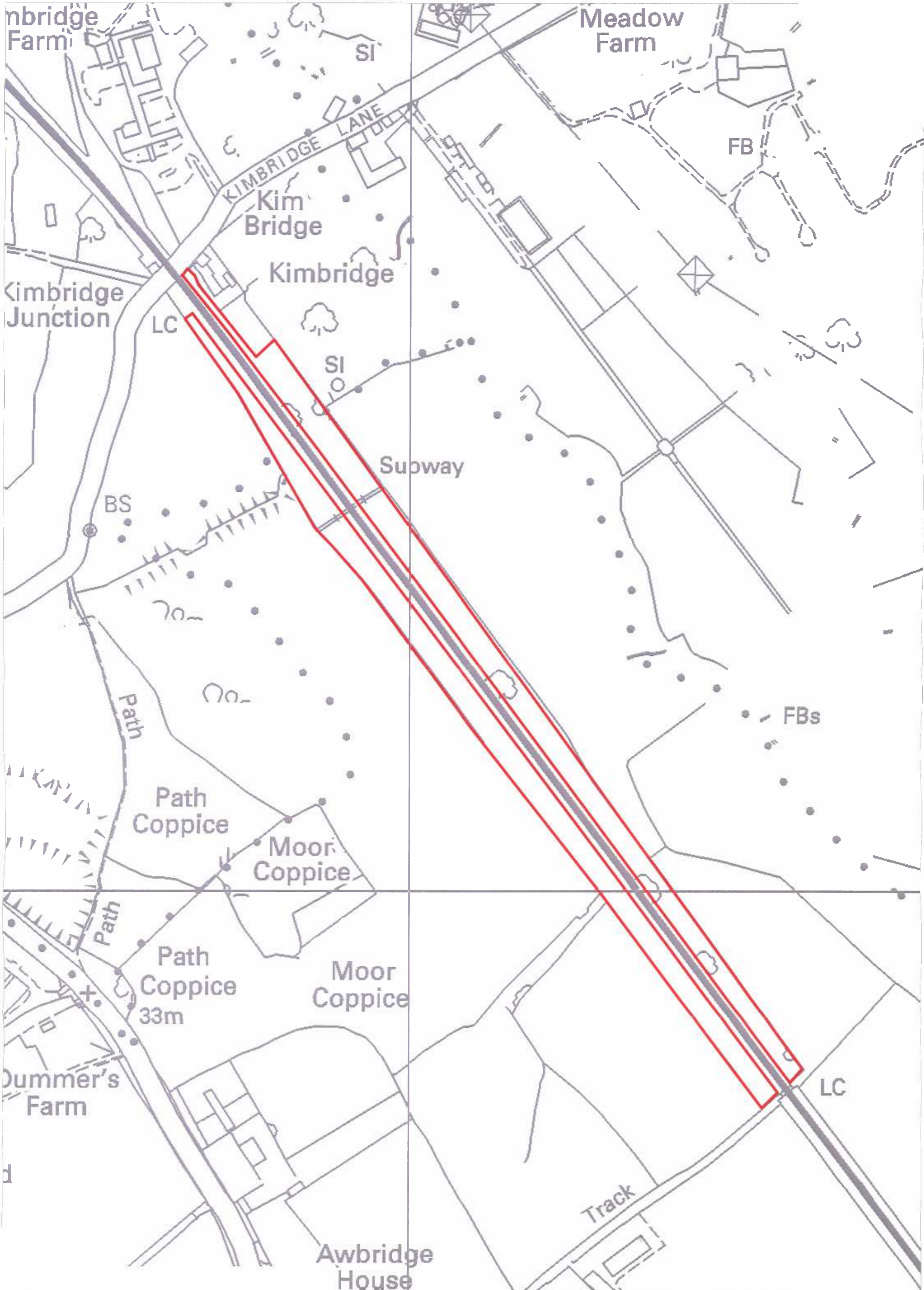
