Statutory Declaration

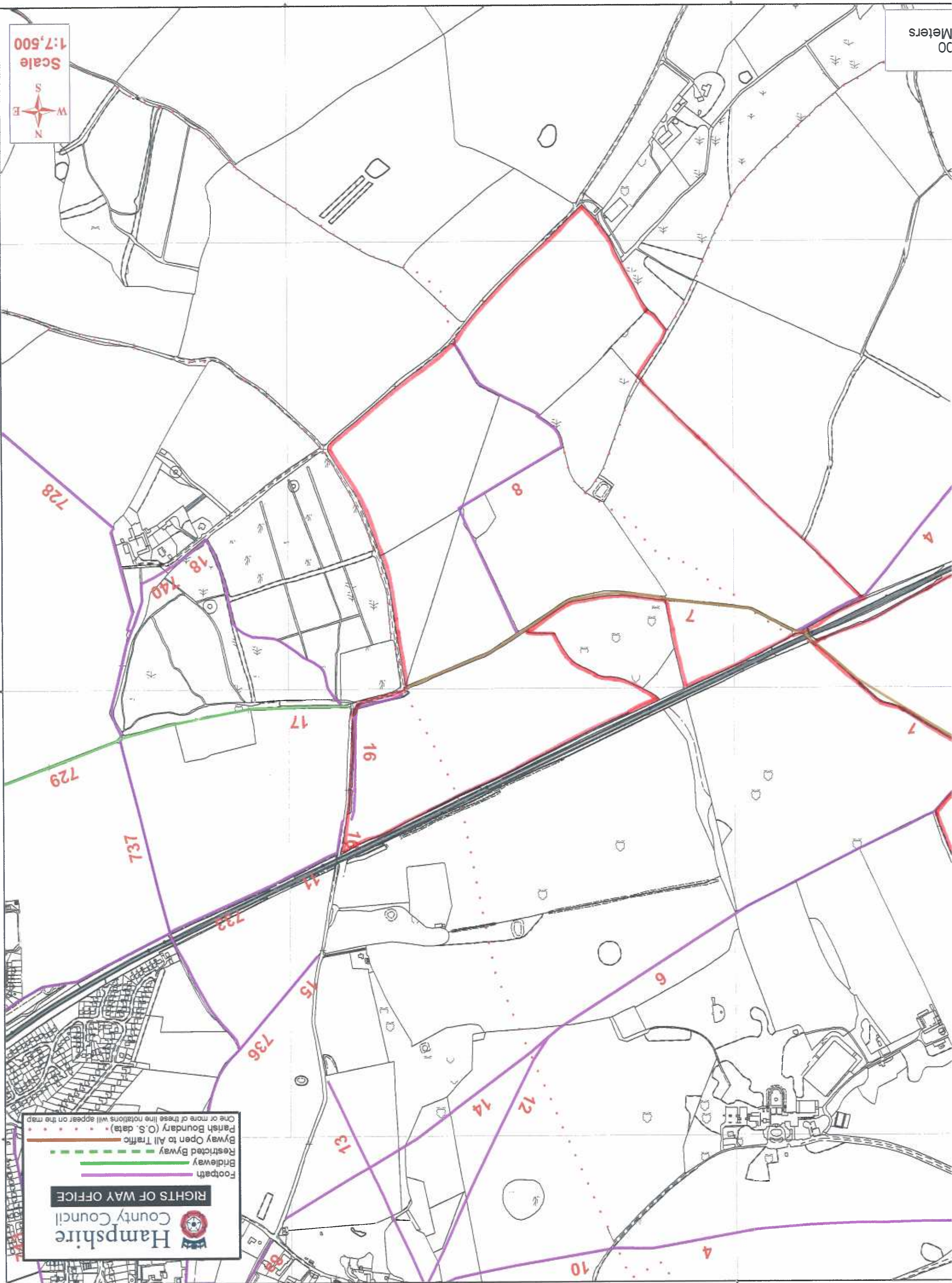

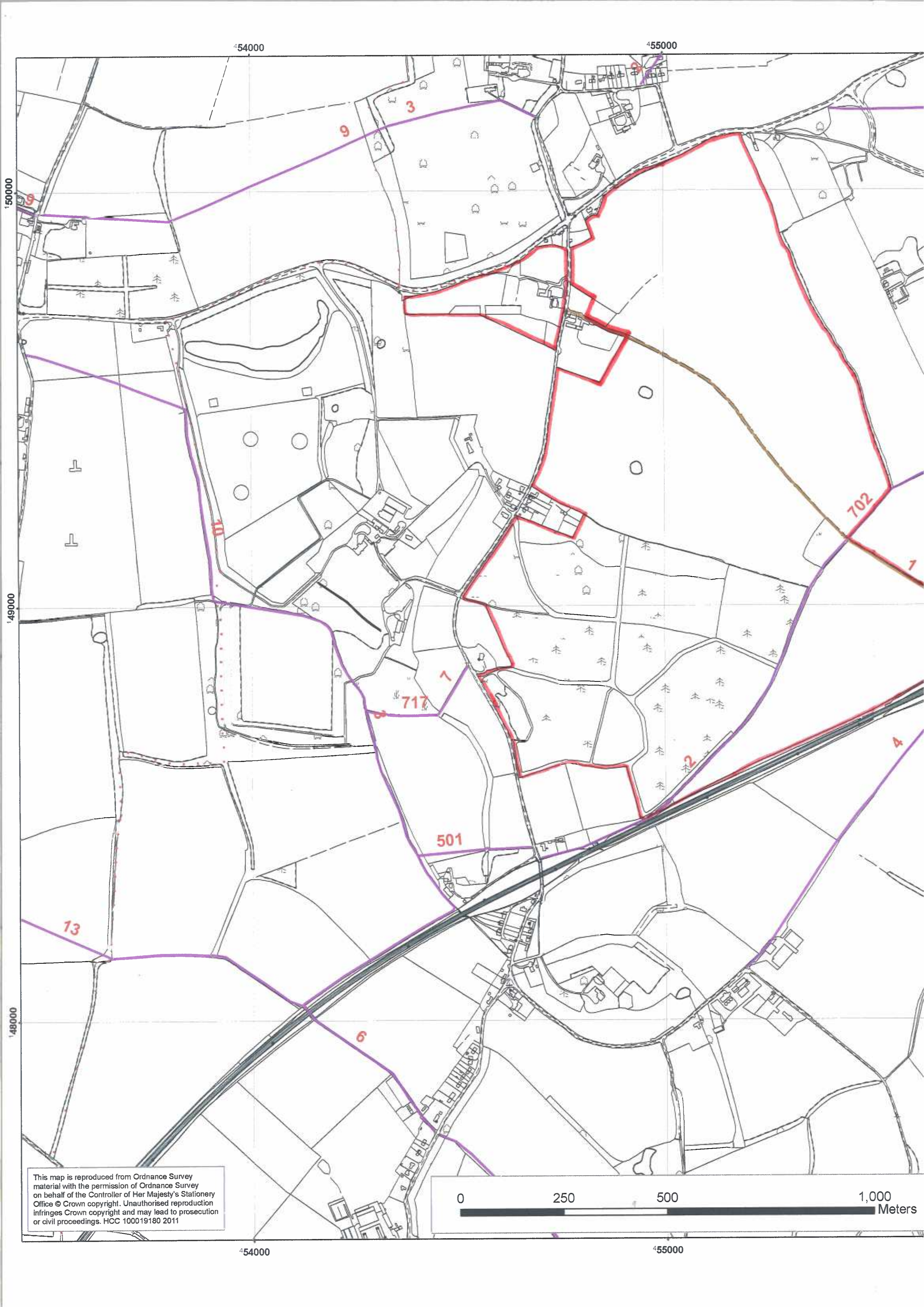
