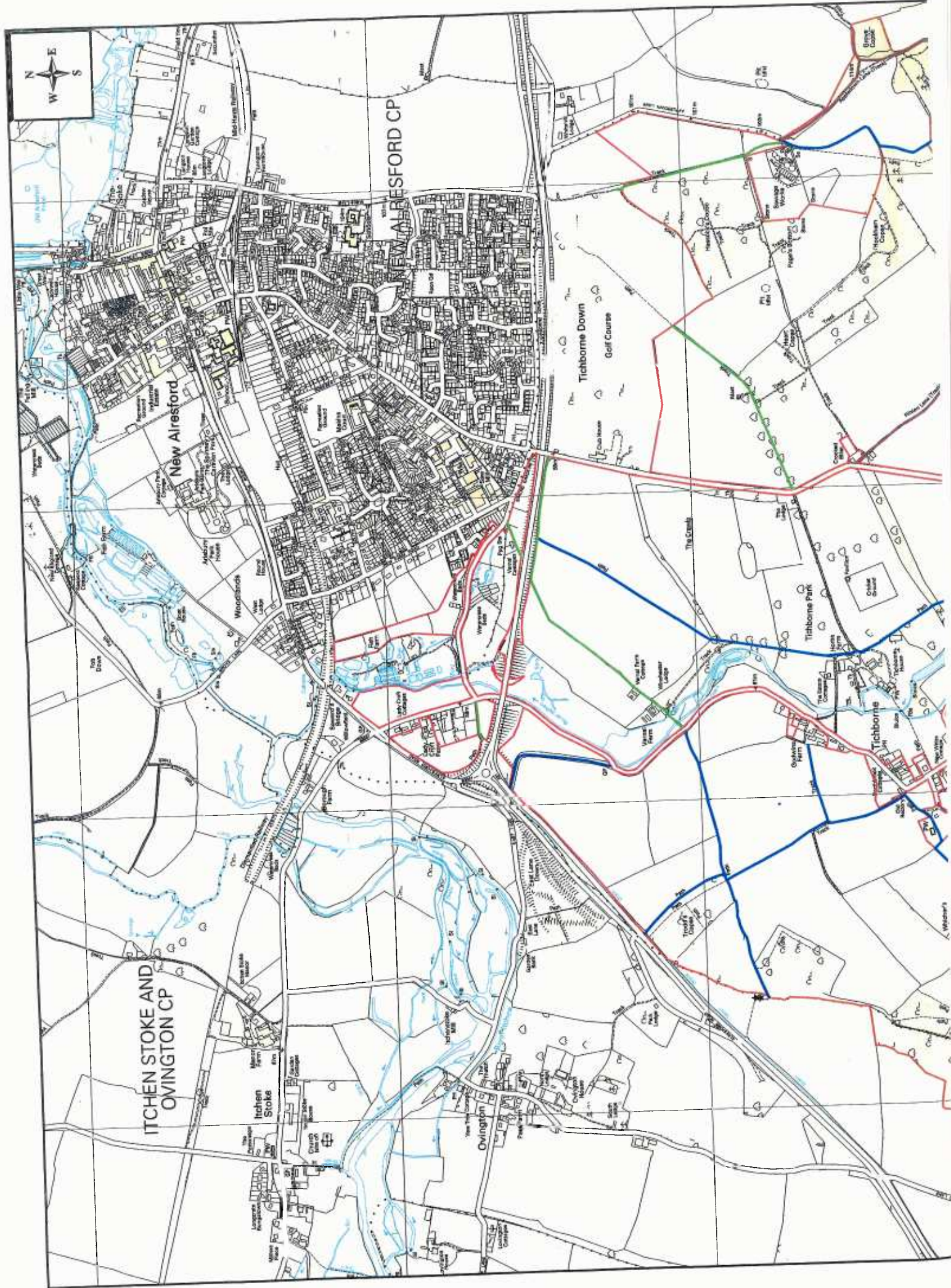

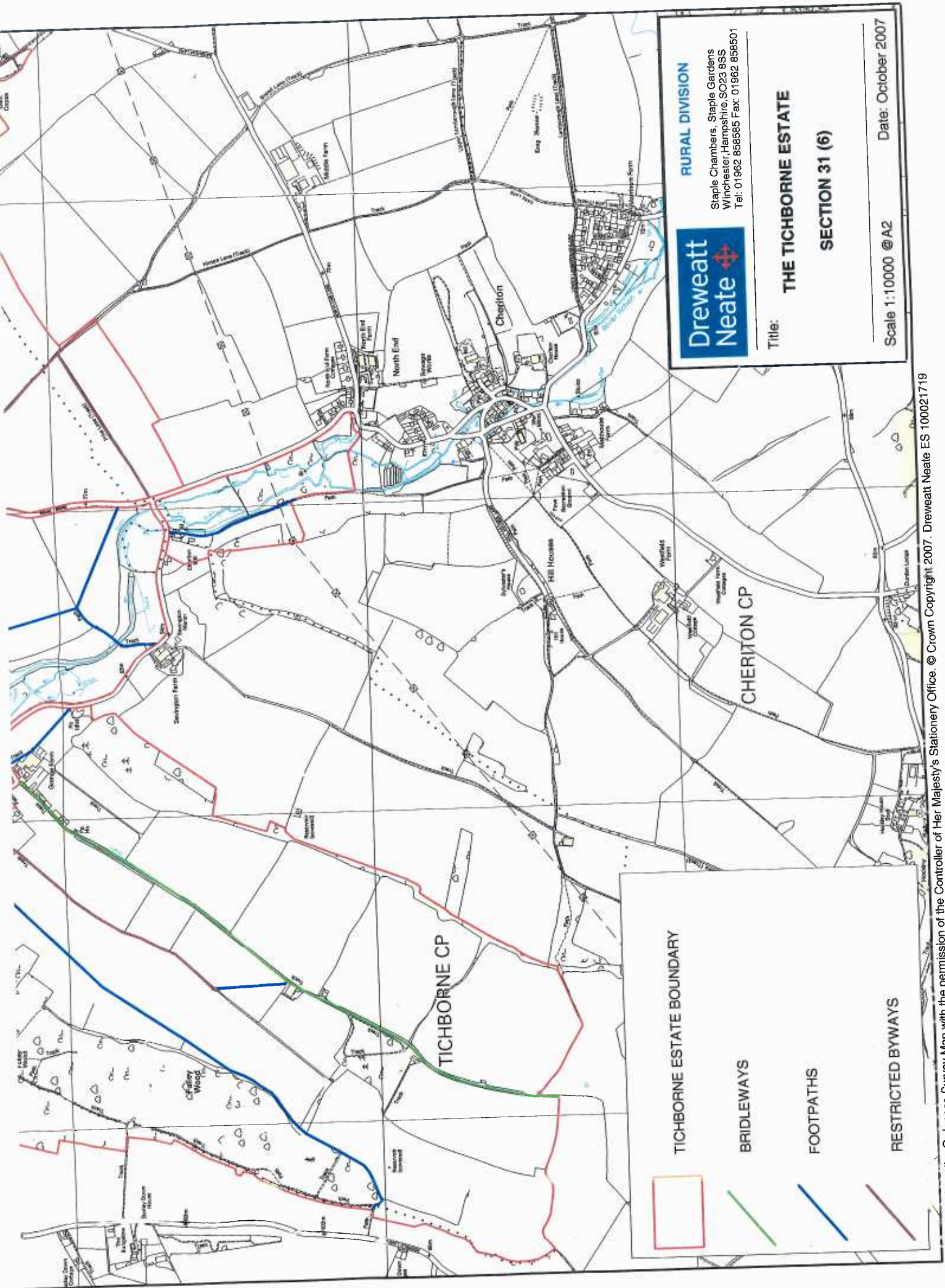

**Statutory Declaration**

**Section 31 (6), Highways Act 1980**

I Christopher Langford as Agent for The Tichborne Estate DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. We have been since time the immemorial owner of the land known as The Tichborne Estate more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the 1st day of November 2007 I deposited with Hampshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that:
  - a. the ways marked blue on the said plan have been dedicated as footpaths
  - b. the ways shown green on the said plan have been dedicated as bridleways
  - c. the ways marked brown on the said plan have been dedicated as restricted byways
3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 30<sup>th</sup> October 2007 referred to in 2. And at the present time I have no intention of dedicating any more public rights of way over my property.
