

STATUTORY DECLARATION

SECTION 31(6) HIGHWAYS ACT 1980

I, THE HONOURABLE RALPH DOUGLAS-SCOTT-MONTAGU of Palace House Beaulieu Hampshire SP4 7ZN DO SOLEMNLY AND SINCERELY DECLARE as follows:-

- 1 I have been and am the owner within the meaning of the above section of the land known as The Beaulieu Settled Estate ("the Property") more particularly shown pink on the plan accompanying this declaration ("the Plan")
- 2 On the 27<sup>th</sup> May 1999 I deposited with the Hampshire County Council, being the appropriate council, a statement accompanied by a plan of part of the Property which stated that the ways coloured red on the plan attached to that statement have been dedicated as footpaths and that no other ways have been dedicated as highways over the Property.
- 3 I have subsequently acquired additional land which now forms part of the Property and was previously part of the Beaulieu Manor Estate. A statement was lodged by my father on 27<sup>th</sup> May 1999 dealing with the Beaulieu Manor Estate which included this additional land. The plan attached to my father's statement showed the footpaths dedicated as highways over the relevant part of what is now my Property.
- 4 I hereby confirm that only the ways coloured red on the plans attached to my statement and the statement of my father are dedicated as highways over the Property and that no additional ways have been dedicated over the Property since the statements dated 27<sup>th</sup> May 1999 referred to above and at the present time I have no intention of dedicating any public rights of way over the Property

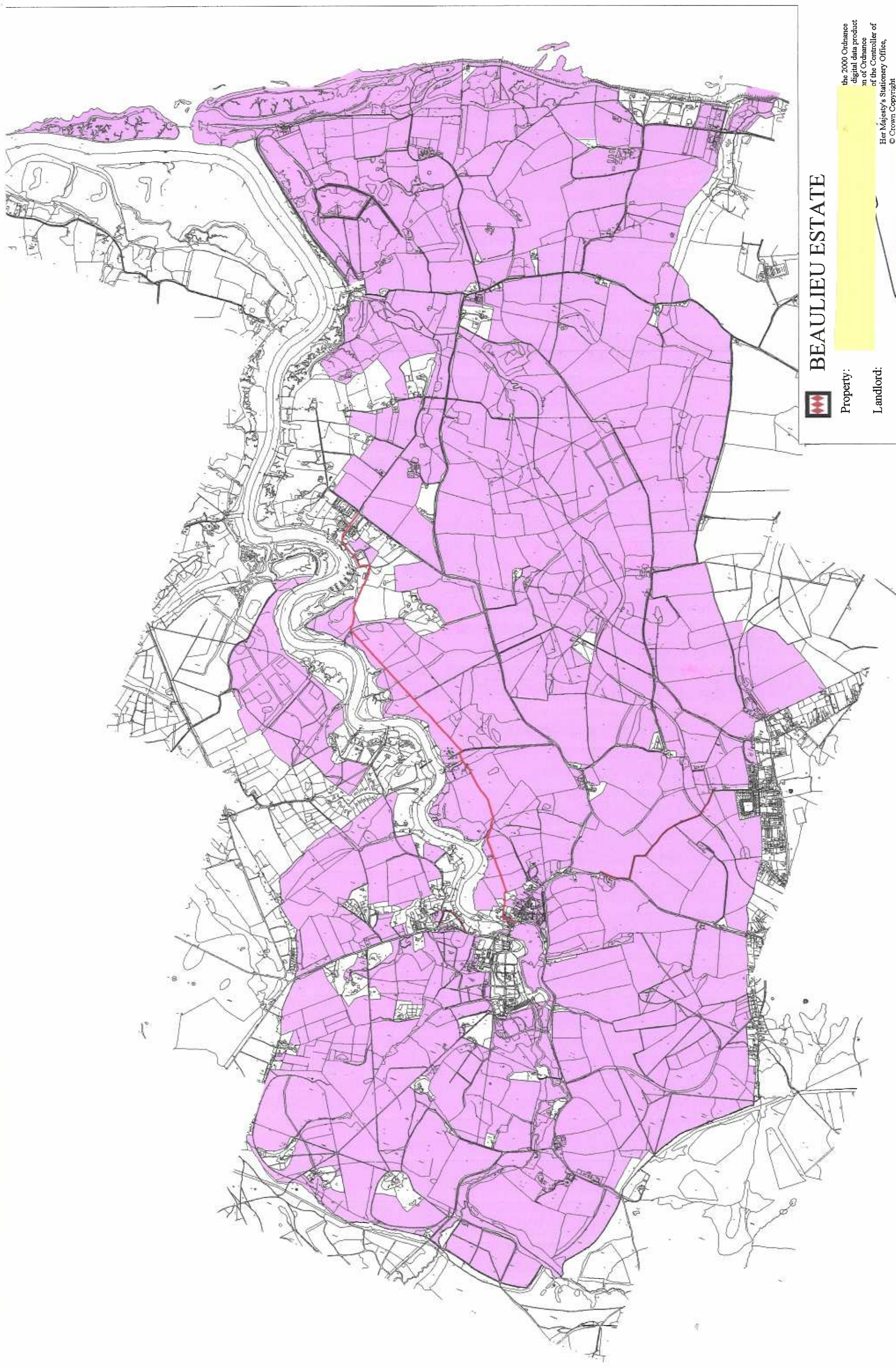
