1. Executive Summary

- 1.1. The purpose of this paper is to seek approval for *New Dimensions in Dance* framework, which outlines a strategy for targeting Hampshire County Council's investment in dance activity, 2014-16 (appendix 1).

2. Background

- 2.1 Dance, as part of the wider arts and museums sector, has an important role in supporting social and economic wellbeing in Hampshire. The *Arts and Museums Strategic Plan, 2012-15 (Connecting Communities to Excellence)* reaffirmed the strategic importance of Dance to Hampshire County Council, and set the scene for a review to maximise the impact of investment into the future.
- 2.2 Currently investment in dance excellence is through 3 primary mechanisms:
- The Culture and Recreation Investment Fund grant aids Dance Up (formerly Hampshire Dance) and The Point
 - Annual Dance Bursaries Scheme, supporting local gifted and talented dancers
 - Wessex Dance Academy (WDA), targeting young people at risk
- 2.3 *New Dimensions in Dance* is the outcome of a review of this current investment within the strategic framework provided by *Connecting Communities to Excellence* and *Hampshire County Council Open for Business*. It has been informed by consultation with key dance providers and stakeholders operating in the Hampshire area and provides the strategic framework for CCBS investment in dance 2014-16. It follows on from the *New Dimensions in Music* strategic framework introduced in 2012.

3. New Dimensions in Dance: Summary

3.1 The County Council is keen to use its targeted investment to inspire innovation and creativity in the way dance providers engage with audiences and connect communities with excellence. We are interested in facilitating opportunities for residents and visitors to participate in dance experiences through a county-wide programme of activities, particularly those that emphasise the value of collaboration and partnership in terms of delivery.

3.2 The following priorities are identified, within the framework of *Open for Business*:

- Engage and encourage new audiences
- Develop skills and support professional development
- Make the most efficient use of resources

Further details on these priorities are provided in appendix 1.

3.3 To meet the aims and priorities of this strategy, the County Council will:

- Continue to support the aims of WDA and evaluate its impact to provide ideas for future development of the project, as a partnership between Culture, Communities and Business Services and Children's Services
- Create a new approach to investment in dance by consolidating the Culture and Recreation Investment Fund and Annual Dance Bursaries Scheme strands and inviting applications by open competition for a commissioned grant delivering against the priorities identified in 3.2 above.

Further details on these proposed actions, and wider commitments, are provided in appendix 1.

4. Finance Implications

4.1 The strategic framework proposes to consolidate the planned investment in dance over the 2014/15 – 2015/16 period as follows:

- 4.2 The allocations during 2014/15 assume a 2% reduction on grants and allow for a 6 month notice period of termination of current funding arrangements for The Point and Dance Up, assuming notice is given in by end March 2014.
- 4.3 The indicative allocations during 2015/16 assume a 10% reduction in grant allocation.

5 Next steps

- 5.1 If approved, the next steps will be to:

Confirm with Dance Up and The Point that they should apply for 6 months funding for 2014/15 according to the ordinary Culture and Recreation Investment Fund criteria and timetable

October 2013: Invite submission of applications for New Dimensions in Dance commissioned grant, 2014-16 by open competition.

End Nov 2013: Deadline for applications

End Jan 2014: Preferred candidate(s) selected

End Mar 2014: Executive Member Culture, Recreation and Countryside approval

Successful candidate(s) notified and current Culture and Recreation Investment Fund recipients notified

October 2014: New Dimensions in Dance begins
