Schools in the Eastern Area of Hampshire below the Government's floor standards based upon 2014 outcomes.

The coalition Government has set floor standards for both primary and secondary schools and has asked Local Authorities to take a robust stance towards those schools below floor to secure rapid improvement.

A primary school is deemed to be below the floor standard if less than 65% of pupils attain Level 4 in reading, writing and mathematics **and** where progress is less than the national median in reading, writing **and** mathematics. In 2014 the national medians were 94% of pupils making two levels of progress in reading, 96% of pupils making two levels of progress in writing and 93% of pupils making two levels of progress in mathematics.

A secondary school is deemed to be below the floor standard if less than 40% of pupils attain 5 A*-C including English and mathematics **and** where progress is less than the national median in both English **and** mathematics. The national medians for 2013 were 74% of pupils making three levels of progress in English and 67% of pupils making three levels of progress in mathematics.
