Annual return for the financial year ended 31 March 2015

Small relevant bodies in England with an annual turnover of £6.5 million or less must complete an annual return in accordance with proper practices summarising their annual activities at the end of each financial year.

The annual return on pages 2 to 5 is made up of four sections:

- Sections 1 and 2 are completed by the person nominated by the body.
- Section 3 is completed by the external auditor appointed by the Audit Commission.
- Section 4 is completed by the body's internal audit provider.

Each body must approve this annual return no later than 30 June 2015.

Completing your annual return

Guidance notes, including a completion checklist, are provided on page 6 and at relevant points in the annual return.

Complete all sections highlighted in red. Do not leave any red box blank. Incomplete or incorrect returns require additional external audit work and may incur additional costs.

Send the annual return, together with your bank reconciliation as at 31 March 2015, an explanation of any significant year on year variances in the accounting statements and any additional information requested, to your external auditor by the due date.

Your external auditor will identify and ask for any additional documents needed for their work. Therefore, unless requested, do not send any original financial records to the external auditor.

Once the auditor has completed their work, certified annual returns will be returned to the body for publication or public display of sections 1, 2 and 3. You must publish or display the annual return, including the external auditor's report, by 30 September 2015.

It should not be necessary for you to contact the external auditor for guidance.

Guidance notes on completing the 2014/15 annual return

- 1 You must apply proper practices for preparing this annual return. But, if this is unavoidable, make sure the amendments are drawn to the attention of and approved by the body, properly initialled and an explanation is provided to the external auditor. - 4 Do not send the external auditor any information not specifically asked for. Doing so is not helpful. However, you must notify the external auditor of any change of Clerk, Responsible Financial Officer or Chair.
- 5 Make sure that the copy of the bank reconciliation which you send to your external auditor with the annual return covers all your bank accounts. If your body holds any short-term investments, note their value on the bank reconciliation. The external auditor must be able to agree your bank reconciliation to Box 8 on the Accounting statements. - 6 Explain fully significant variances in the accounting statements on page 2. Do not just send in a copy of your detailed accounting records instead of this explanation. The external auditor wants to know that you understand the reasons for all variances. Include a complete analysis to support your explanation. There are a number of examples provided in the Practitioners' Guides* to assist you.
- 7 If the external auditor has to review unsolicited information, or receives an incomplete bank reconciliation, or you do not fully explain variances, this may incur additional costs for which the auditor will make a charge.
- 8 Make sure that your accounting statements add up and the balance carried forward from the previous year (Box 7 of 2014) equals the balance brought forward in the current year (Box 1 of 2015).

Supplementary paper to Section 4 – Annual internal audit report 2014-15

Assurance obtained from other HCC internal audit coverage:

- A: Accounting records
 - SAP, the corporate accounting system, is used and maintained for recording transactions through the year for Solent Transport. A SAP main accounting system internal audit review is included in the audit universe.
- B: Expenditure
 - Invoices are processed and paid centrally by Finance. A regular Accounts Payable internal audit review is undertaken.
- D: Budgetary Control
 - Corporate financial procedures detail the requirements for budgetary control and these are available on the intranet. Budget monitoring for the unit is supported by the DFU, and a regular internal audit review of budgetary control is included within the Internal Audit Plan.
- G: Salaries
 - Salaries are processed and paid centrally, with relevant costs charged directly to the relevant cost centre. Annual HR and Payroll internal audit reviews are included within the Internal Audit Plan.
- I: Bank Reconciliations
 - All transactions are paid through a central HCC bank account, and the relevant transactions are coded to the relevant cost centre. A regular bank reconciliation internal audit review is included within the Internal Audit Plan.

Audit Findings

- B: Payments
 - In some instances supporting documentation was not available to confirm the value for items of expenditure included in the statement of accounts, although reasonable explanation was given to confirm validity of transactions
- C: Risk management
 - A risk register is contained in the TfSHIoW Business Plan 2013-15, and was reported to the TfSH Joint Committee on 7 June 2013. This

ensures that risks are assessed and considered by the Joint Management Committee.

- D: Budgetary Control
 - No issues arising
- E: Income
 - No issues arising
- F: Petty Cash
 - No petty cash payment therefore not applicable
- H: Assets and Investment
 - No assets or investments therefore not applicable
