1. The decision:

- 1.1. That unconditional approval be given to the following proposal; published by Hampshire County Council under Section 19 (1) of the Education and Inspections Act 2006:

To make a prescribed alteration to Cornerstone CE (Aided) Primary School, Bader Way, Whiteley, Fareham PO15 7JH (category of school – Aided C of E) by relocating and enlarging the premises of the school, with effect from 1 September 2018.

2. Reason(s) for the decision:

- 2.1. Formal consultation on the enlargement of Cornerstone CE (Aided) Primary School to relocate change the capacity of the school from 210 places to 630 places took place between 25 January 2016 and 4 March 2016.
- 2.2. Following the consultation a public notice was published on 29 April 2016 outlining the expansion of the school with effect from 1 September 2018. No objections were received.
- 2.3. A copy of the Public Notice is appended. The County Council complied with all statutory requirements relating to the publication of the Public Notice.
- 2.4. In accordance with the procedure approved by Hampshire County Council's Cabinet on 21 May 2007, power to make this decision is delegated to the Director of Children's Services.
- 2.5. The reason for making this decision is that this will provide additional capacity for children of primary school age within the school catchment area where a significant shortfall has been identified.

3. Other options considered and rejected:

- 3.1. Not to approve the proposal would mean that there are insufficient primary school places available in the school to meet the demand from within the North Whiteley area.



RELOCATION AND ENLARGEMENT**

PLEASE NOTE THIS REPLACES THE PUBLIC NOTICE DATED 15 APRIL 2016

1. Notice is hereby given, in accordance with Section 19(1) of the Education and Inspections Act 2006, that Hampshire County Council intends to make a prescribed alteration to **CORNERSTONE C of E (AIDED) PRIMARY SCHOOL**, Bader Way, Whiteley, Fareham, Hampshire, PO15 7JH (category of school – Aided C of E) by relocating and enlarging the premises of the school, with effect from 1 September 2018.
2. The current capacity of Cornerstone C of E (Aided) Primary School is for 210 pupils. The current number of pupils registered at the school is 102. The relocation and enlargement of accommodation will be provided with effect from 1 September 2018. From that date the school will have a total capacity for 630 pupils. The current admission number for the school is 30 and this will increase to 90, in phases, on the implementation of this proposal.
