1. The decision:

- 1.1. That unconditional approval be given to the following proposal; published by Hampshire County Council under Section 19 (1) of the Education and Inspections Act 2006:

To make a prescribed alteration to NORTH BADDESLEY INFANT SCHOOL AND NORTH BADDESLEY JUNIOR SCHOOL, Botley Road, North Baddesley, Southampton, SO52 9EE (category of schools – Community) by enlarging the premises of the schools, with effect from 1 September 2018.

2. Reason(s) for the decision:

- 2.1. Formal consultation on the enlargement of NORTH BADDESLEY INFANT SCHOOL AND NORTH BADDESLEY JUNIOR SCHOOL to change the capacity of the infant school from 210 places to 270 places and the junior school from 256 places to 360 took place between 8 February 2016 and 18 March 2016.
- 2.2. Following the consultation a public notice was published on 15 April 2016 outlining the expansion of the school with effect from 1 September 2018. No objections were received.
- 2.3. A copy of the Public Notice is appended. The County Council complied with all statutory requirements relating to the publication of the Public Notice.
- 2.4. In accordance with the procedure approved by Hampshire County Council's Cabinet on 21 May 2007, power to make this decision is delegated to the Director of Children's Services.
- 2.5. The reason for making this decision is that this will provide additional capacity for children of primary school age within the school catchment area where a significant shortfall has been identified.

3. Other options considered and rejected:

3.1. Not to approve the proposal would mean that there are insufficient primary school places available in the school to meet the demand from within the catchment area.



NORTH BADDESLEY INFANT AND JUNIOR SCHOOLS - ENLARGEMENT

1. Notice is hereby given, in accordance with Section 19(1) of the Education and Inspections Act 2006, that Hampshire County Council intends to make a prescribed alteration to **NORTH BADDESLEY INFANT AND JUNIOR SCHOOLS**, Botley Road, North Baddesley, Southampton, Hampshire, SO52 9EE (category of school – Community) by enlarging the premises of the schools, with effect from 1 September 2018.
2. The current capacity of North Baddesley Infant School is for 210 pupils. Additional permanent accommodation will be provided with effect from 1 September 2018. From that date the school will have a total capacity for 270 pupils. The number of pupils registered at the school in the 2015/16 school year is 210. The current admission number for the school is 60 and this will increase to 90 on the implementation of this proposal.
3. The current capacity of North Baddesley Junior School is for 256 pupils. Additional permanent accommodation will be provided with effect from 1 September 2018. From that date the school will have a total capacity for 360 pupils. The number of pupils registered at the school in the 2015/16 school year is 250. The current admission number for the school is 64 and this will increase to 90 on the implementation of this proposal.
