Summary of Bid/ Project	<p>You Decide will support small projects of local priority that aim to make improvements to local neighbourhoods so that they are better, safer places to live. The projects will be generated by the local community. The scheme could support a wide range of projects including:</p> <ul style="list-style-type: none"> • Environmental improvements such as skips for neighbourhood clean ups or a community garden. • Activities and opportunities for vulnerable groups. • Purchase of safety equipment such as security locks for a garage block • Improving safety to community buildings through repairs • Promoting a healthier lifestyle away from alcohol, drugs or crime <p>HAT members will be asked to comment on the scheme criteria/guidance before this is finalised.</p>

<p>How does the Bid meet the HATs Term of Reference?</p> <p>1) To tackle economic, social and health inequalities in the local area</p> <p>2) To support the delivery of Hampshire’s improvement priorities within the Hampshire Local Area Agreement*</p> <p>3) To support local highways and transport priorities**</p>	<p>The scheme will directly involve local people in making decisions on the priorities and spending for a proportion of the Gosport HAT budget.</p> <p>This request for funding is for a first round of proposals (£10,000) will be invited from the Town Ward which has already been identified by Gosport HAT members as their area of geographic focus due to it experiencing the greatest levels of deprivation (10 LSOA’s in the 20% most deprived in England).</p> <p>The invitation to put forward proposals will set out the role of the HAT in supporting local communities to tackle the economic, social and health inequalities that are most important to them.</p> <p>The scheme will also provide a positive opportunity to promote the role of HATs and local members in supporting local improvements.</p>
<p>Timescale (What is the anticipated period over which the money will be spent?)</p>	<p>Commencement Date: July 2010</p> <p>Completion Date: October 2010</p>
<p>Intended Outcomes (How will the success of the bid/project be measured?)</p>	<p>An evaluation of the event will be completed to establish the extent to which local residents found this approach valuable. It will include: number of bids/suggestions received, types of projects bidding, level of public involvement throughout the process, attendees for events, elected member support, qualitative feedback from participants and bidders at the event, percentage of those willing to participate again in future events, monitoring and evaluation data from projects. (Applicants will be required to provide a short report on the impact of each of their projects. A simple A4 template will be provided to facilitate</p>

	this and to secure a consistent response).
Future Funding Arrangements (If the project is to last more than a year how will it be funded in subsequent years? How will any outcomes achieved by the project be sustained in the longer term? It is expected that projects will be one-off schemes/short-term initiatives to resolve immediate community issues or concerns (e.g. equipment for youth activities or a gardening club) or will serve to pump-prime a community initiative that can then be self-sustaining (e.g. training of community volunteers such as street pastors or young leaders) Should this approach prove successful it is expected that further application rounds will be run but that these will support new areas, groups and initiatives. We would also intend to explore the opportunity to roll this out to other HAT areas.
