1. Summary

- 1.1. This report covers three issues which the Marine Director is currently progressing, namely the Asset Enhancement Programme, the Strategic Vision and the recruitment of two new members of the Harbour Board.

2. Asset Enhancement Programme

- 2.1. The Asset Enhancement Reserve currently stands at £314,000. At its meeting on 8 April, the Harbour Board agreed that two of the proposed Asset Enhancement projects, namely the extension to the Hamble Jetty and the improved tender storage facility on the Hamble Jetty, should be submitted to Eastleigh Borough Council for pre-application planning advice. This has since been done, although the results have not yet been received. Estimated costs for these two projects are at Appendix 1. - 2.2. Subsequently, drawings and estimated costs for two other proposed projects have been received. These are for the dinghy launching pontoon at Hamble and improved tender storage facilities on the Warsash Jetty. Estimated costs for these two projects are at Appendix 2. Plans can be viewed on-line at <http://www3.hants.gov.uk/hambleharbour/dues-moorings.htm> and hard copies will be available for viewing at the meeting.

3. Strategic Vision

- 3.1. The Strategic Vision sub-group appointed by the Management Committee at its meeting on 7 January has met three times and a first draft of a 'Strategic Vision for the River Hamble' has been written. This will be considered by

the sub-group at its next meeting, prior to submission to the Management Committee in September. The draft takes into account the views expressed by members of the Management Committee but, to date, no wider consultation has taken place.

4. Harbour Board appointments

- 4.1. Two independent members of the Harbour Board (Tony Lovell (Recreational Boating) and Chris Moody (Commercial)) have reached the end of their initial six year terms and the process to select their replacements has now been completed. The vacancies were widely advertised from mid-April, with a closing date of 9 May. Eight applications were received, four for the Recreational Boating member and three for the Commercial member, plus one applicant who did not express a preference. All eight candidates were interviewed on 24 May by an Appointments Panel comprising Councillor Keith Evans (Harbour Board Chairman) – Chairman, Wanda Fojt (Area Manager, Natural England), Bob Russell (Chairman, RYA Southern Region), John Dodd (Chairman, BMF Southern Area) and Jill Roberts (Hampshire County Council Human Resources Department). The Panel selected the following:

Recreational Boating: David Jobson (subject to ratification by the County Council)

Commercial: Chris Moody (for a second term)

- 4.2 This leaves a vacancy on the Management Committee for a Berth and Mooring Holders' Representative. The position was widely advertised on 27 May, with a closing date for nominations of 20 June.

5. Recommendation
