Definitions:

Children are eligible for SPP if they meet one of the following criteria:

- *one of their parents is serving in the regular armed forces (including pupils with a parent who is on full commitment as part of the full-time reserve service);*
- *they have been registered as a 'service child' on a school census in the past 6 years;*
- *one of their parents died while serving in the armed forces and the pupil receives a pension under the Armed Forces Compensation Scheme or the War Pensions Scheme;*
- *one of their parents is in the armed forces of another nation and is stationed in England.*

Proof of this criterion may be provided in an official letter, such as a posting note or letter of support from the service parent's Commanding Officer, confirming employment, or evidence of the receipt of a Service pension. This should include a relocation date and the Unit postal address (where relevant).
