

# Hampshire Prosperity Partnership Board – Conflicts of Interest Registration Guidance Notes

## PURPOSE OF THE REGISTER

The purpose of the Register of Interests of Members of the Hampshire Prosperity Partnership Board (HPPB) is to list direct or indirect pecuniary interests or other material benefits appropriate to the HPPB's activities that a Member receives which members of the public might reasonably think could lead to a conflict of interest arising in his or her participation in the decisions of the HPPB, or action taken in his or her capacity as a Member of the HPPB. Board members should also register the interests of close family members and persons living in the same household as the Board Member. Close family members include personal partners, parents, children (adult and minor), brothers, sisters, and the personal partners of these.

Members are required to keep that overall purpose in mind when registering their interests. It is left to individual Members to give the required information; each Member is ultimately responsible for his or her own entry and for keeping their entries up to date. Registration of interests is an additional safeguard against the inadvertent omission of Members' declaration of any relevant interest at the time when they contribute to the discussions, considerations and decisions of the HPPB or when they communicate with other Members or with Hampshire County Council staff.

## THE CATEGORIES OF REGISTERABLE INTERESTS

Interests are registered under six categories, which are represented by the following headings.

### **1. Remunerated Directorships, Partnerships and Trusteeships**

Members are required to register remunerated directorships, partnerships or trusteeships which they may hold in public or private companies, partnerships or trusts with which Hampshire County Council is currently contractually involved or where there is some reasonable likelihood of a future contractual involvement. This also applies to directorships which may themselves be unremunerated but where the companies in question are associated with or subsidiaries of a company in which the Member holds a remunerated directorship.

### **2. Remunerated employment, office, profession etc.**

Members are required to register outside employment, professions and sources of remuneration not covered elsewhere. However, this would apply only to connections with public or private companies with which Hampshire County Council is currently contractually involved or where there is some reasonable likelihood of a future contractual involvement.

### **3. Registerable shareholdings**

Members are required to register the name of any public or private company or other body in which, to their knowledge, they have a beneficial interest in a shareholding having a nominal value greater than 1% of the issued share capital of the company or body. This requirement applies only to public or private companies with which Hampshire County Council is currently contractually involved or where there is some reasonable likelihood of a future contractual involvement. The requirement does not apply to shareholdings controlled on a discretionary basis by investment managers and which are outside the Member's day-to-day control.

### **4. Registerable interest in land or property**

Members are required to register the details of any land or property in which the Member has a direct interest. This requirement applies only in circumstances where Hampshire County Council is contractually involved or where there is some reasonable likelihood of a future contractual involvement in relation to that land or property.

### **5. Miscellaneous and unremunerated interests**

This is for use by Members wishing to register interests, including unremunerated interests, which do not clearly fall within any of the specific categories above but which they consider to be relevant to the definition of the purpose of the Register of Interests (see first paragraph above).

## **6. Other interests**

Members register their other interests under this section.

*Members are not required to disclose the **amount** of any remuneration or benefit they receive in respect of their registerable interests.*

## **NOTIFICATION OF CHANGE OF CIRCUMSTANCES**

Each HPPB Member shall review their individual register of interests before each board meeting and decision-making committee meeting, submitting any necessary revisions to Hampshire County Council at the start of the meeting. Any recorded interests relevant to the meeting should also be declared at this point.

Even if a meeting has not taken place a Member of the Board must, within 28 days of becoming aware of any change to the interests specified below, provide written notification to Hampshire County Council of that change.

As well as being required for Board Members, conflict of interest extends to cover close family members of the Board.

“Close Family Member” includes a Board Member’s close relatives and persons living in the same household including but not limited to the Board Member’s spouse, civil partner or cohabitant, the Board Member’s children, parents, brothers, sisters, grandchildren, grandparents and their personal partners.

Where any Close Family Member has recently been involved in any activity which would have been declarable by the Board Member, this should be declared, with the date the activity ended.
