

# Hampshire Prosperity Partnership Board – Register of Members’ Interests

**NOTIFICATION OF CHANGE OF CIRCUMSTANCES**

Each HPPB Member shall review their individual register of interests before each board meeting and decision-making committee meeting, submitting any necessary revisions to Hampshire County Council at the start of the meeting. Any recorded interests relevant to the meeting should also be declared at this point.

Even if a meeting has not taken place a Member of the Board must, within 28 days of becoming aware of any change to the interests specified below, provide written notification to Hampshire County Council of that change.

As well as being required for Board Members, conflict of interest extends to cover close family members of the Board.

“Close Family Member” includes a Board Member’s close relatives and persons living in the same household including but not limited to the Board Member’s spouse, civil partner or cohabitant, the Board Member’s children, parents, brothers, sisters, grandchildren, grandparents and their personal partners.

Where any Close Family Member has recently been involved in any activity which would have been declarable by the Board Member, this should be declared, with the date the activity ended.
