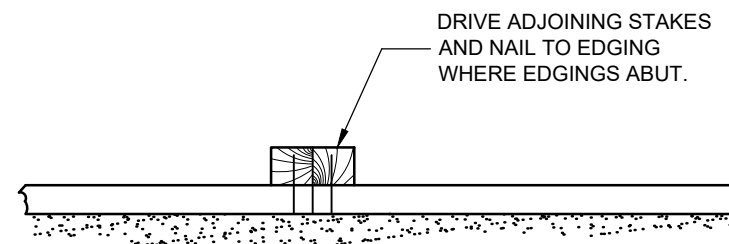


FOOTWAY TYPE 4 - RURAL



PLAN DETAIL 'A'
(SEE NOTE 5)

NOTES

1. ALL DIMENSIONS ARE IN MILLIMETRES.
2. SELF BINDING PATH GRAVEL SHALL BE AS SPECIFIED IN CLAUSE 1174AR.
3. TIMBER FOR PATH EDGINGS AND STAKES SHALL BE LARCH OR DOUGLAS FIR PRESERVED IN COMPLIANCE WITH CLAUSE 311. CREOSOTE SHALL NOT BE USED.
4. STAKES SHALL BE DRIVEN AT NOT GREATER THAN 1000 CENTRES AND EDGING TIMBER SHALL BE FIXED TO EACH STAKE BY 2 No. 80 LONG GALVANISED NAILS.
5. WHERE FOOTWAY EDGINGS ABUT THEY SHALL BE SECURED AS SHOWN IN DETAIL 'A'.
6. SUBBASE SHALL BE ONE OF THE MATERIALS COMPLYING WITH CLAUSE 803 OR CLAUSE 807 AS SPECIFIED IN THE WORKS INFORMATION.
7. WHERE SPECIFIED IN APPENDIX 11/1 GEOTEXTILE SHALL BE LAID ON FORMATION TO THE FULL WIDTH OF THE FOOTWAY.
8. EDGING LEVELS ARE SCHEDULED IN APPENDIX 11/1. WHERE BOTH EDGING LEVELS ARE THE SAME THE FOOTWAY SHALL BE FORMED WITH A CENTRAL CAMBER FALLING 2.5% TO EITHER SIDE.
