## 1. Introduction

The Friends of Ringwood Forest (FoRF) Regulation 24 Public Consultation Response is submitted to raise Community concerns addressing potential harm to the future of a cherished amenity identified in the Hampshire Minerals & Waste Plan (HM&WP) as “Purple Haze” which lies within Ringwood Forest contiguous to Moors Valley Country Park.

Community concerns have been raised continuously by FoRF since development of the Purple Haze site was first mooted, initially as a landfill & minerals site and now identified solely for sand & gravel extraction. We are encouraged to note that some of our concerns have now been addressed by Policy changes within the current Submission Plan.

However, no great certainty is offered in the Submission Plan which adequately guarantees that the development of the Purple Haze site allocation will do no harm to Ebblake Bog & the Moors River System. We also note that the East Dorset Environment Partnership (EDEP) consultation response will expertly present the significant environmental, ecological & hydrological reasons why Purple Haze must be removed from the Submission Plan for it to be legally compliant and sound.

Collaboration with the East Dorset Environment Partnership (EDEP), and others, has enabled FoRF to contribute to the myriad of environmental, ecological & hydrological concerns EDEP has tirelessly pursued when considering the potential development of the Purple Haze allocation. **In order to avoid unnecessary duplication of those concerns, PLEASE NOTE that FoRF fully supports the EDEP Regulation 24 Public Consultation Response in its entirety.**
