Following previous [STOP PRESS](#) Employer communications issued, this email sets out the requirements of Scheme Employers and guidance to enable you to do this.

McCloud data collection is a statutory obligation because it is proposed that legislative changes will be made to the LGPS to remove the unlawful age discrimination by extending underpin benefits to eligible younger members. Employers are legally required to provide administering authorities with the information they need to calculate members benefits. Attached you will find:
