## Statutory Declaration

### Section 31 (6), Highways Act 1980

I Mr C. A. H. Wills DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since <sup>th</sup> 5 April 1986 the owner of the land know as Litchfield Farm more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the 4<sup>th</sup> day of November 1998 I deposited with Hampshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that ( *the ways coloured brown on the said plan and on the plan accompanying this declaration had been dedicated as highways with vehicular status*) ( *the ways coloured green on the said plan and on the plan accompanying this declaration had been dedicated as bridleways* ) ( *the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as footpaths*) ( *no (other) ways had been dedicated as highways over my property*).
3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 4<sup>th</sup> November 1998 referred to in 2. above ( *since the date of the statutory declaration referred to in 3. above*) ( *other than those (highways with vehicular status) (bridleways) (footpaths) marked in the appropriate colour on the plan accompanying this declaration*) and at the present time I have no intention of dedicating any more public rights of way over my property.

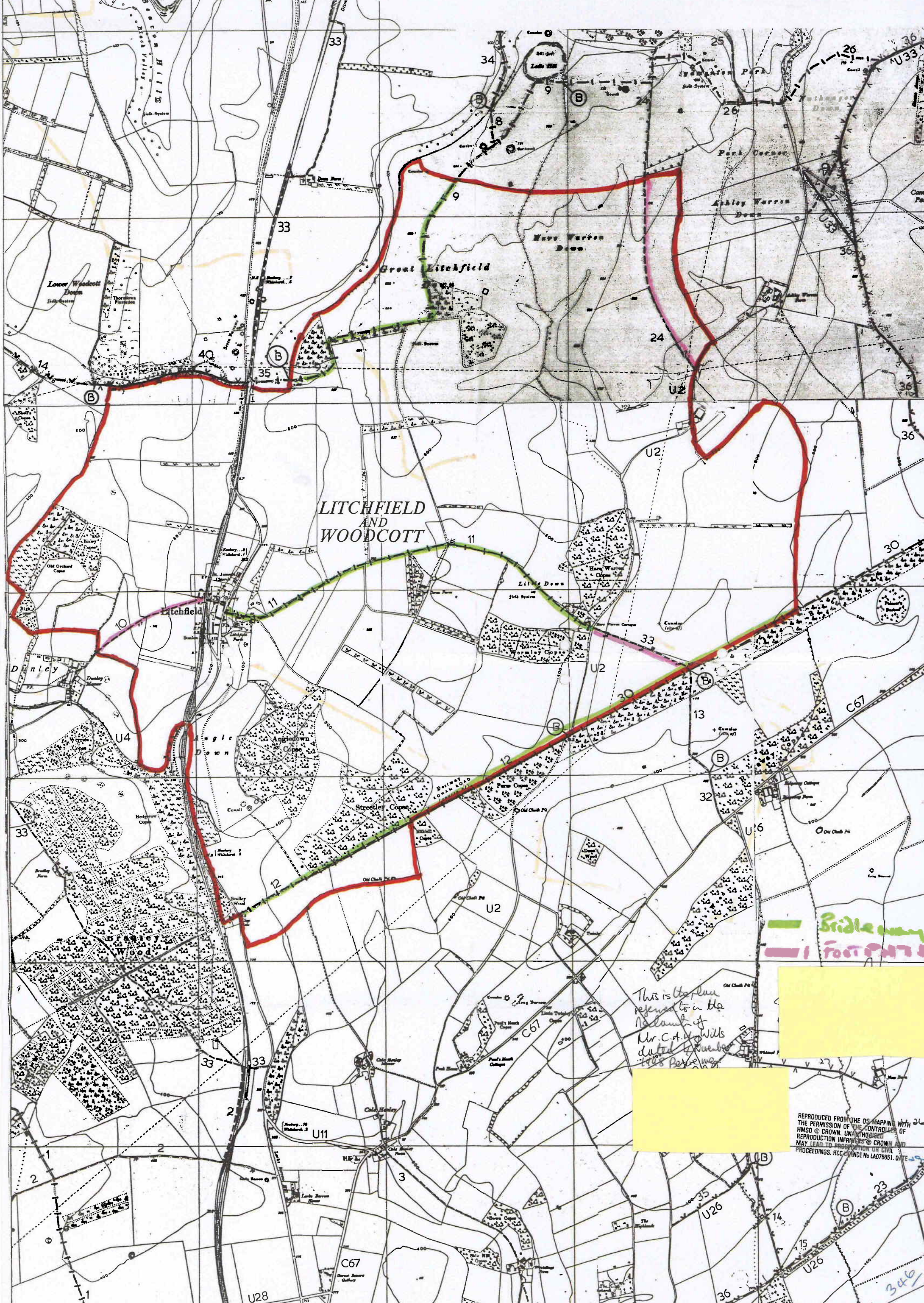
