<b>Bossington 1</b>	Footpath	3342 3065 Road C17	3426 3022 Houghton 10 at Parish Boundary	<u>From Road C.17 opposite entrance to Bossington Farm to Parish Boundary</u> From Road C.17 through field gate, eastwards along verge of pasture on south side of wire fence, through field gate eastwards and southeastwards along track, through field gate, then along track, across 8 ft. wide bridge over River Test, along 8 ft. wide track, across bridge, along grass track, across footbridge, along grass track, across 8 ft. wide bridge, along track, through field gate, then southeastwards across pasture to stile at railway fence on Parish Boundary.
<b>Bossington 2</b>	Restricted Byway	3165 3148 Broughton 27 at Parish Boundary	3180 3114 Beech Tree Walk	<u>From Road C.147 to Parish Boundary</u> From Road C.147 northwestwards along track through woodland to Parish Boundary.
<b>Bossington 3</b>	Bridleway	3233 3033 Road U83	3293 2988 Road C17	<u>From Road C.17 to Road U.83</u> From Road C.17 northwards and then westwards along roughly metalled track 7 ft. wide between fences 20 ft. apart, then along northern boundary of field, through two gateways, then along grass track 10 ft. wide between hedge and fence 20 ft. to 25 ft. apart then northwards along earth track to Road U.83.
<b>Bossington 4</b>	Footpath	3240 2879 Mottisfont 18 at Parish Boundary	3277 2870 Road C17	<u>From Road C.17 to Parish Boundary</u> From Road C.17 at culvert, west-northwestwards through spinney on south side of stream, over wire fence, along verge of pasture on south side of wire fence, through field gate, and along grass track on north side of work to slip rails at Parish Boundary.
<b>Bossington 501</b>	Footpath	3410 2920 Kings Somborne 501 at Parish Boundary	3426 3021 Houghton 501 at Parish Boundary	Minimum 2.44 metres wide
