<b>Bramshaw 2</b>	Footpath	2654 1664 Footpath 1	2686 1717 Road C107	<u>From No. 1 at St. Peter's Church, to junction with Road C.107</u> From No. 1 at stile, northeastwards along undefined path across arable field, over stile, along headland of arable field on southeast side of hedge, over stile, along verge of pasture on southeast side of wire fence, along 12 ft. wide grass headland of arable field, through gap, along earth track approx. 20 ft. wide enclosed between wire fence and hedge, through gap, along earth track 12 ft. wide between hedge and wire fence, and through field gate to junction with C.107.	
<b>Bramshaw 3</b>	Footpath	2704 1669 Junction U137 and Harley Lane	2709 1601 Road U137	<u>From Road U.137, opposite Barford Copse, to junction with Road U.137</u> From U.137, over stone culvert, eastwards along gravel road approx. 7 ft. wide enclosed 20 ft. to 30 ft. wide between farm buildings and hedge, along road on verge of common, then skirting southwest of farm, over stile at swing gate, southwards along undefined path across pasture, over stile at field gate, along track on verge of pasture east of Ryan's Farm and over stile at field gate to junction with U.137.	That part of the path which ran between 2713 1612 and 2703 1603 has been diverted and now runs between 2713 1612 and 2709 1601  1.5 metres wide between 2709 1601 and 2713 1612
<b>Bramshaw 4</b>	Footpath	2732 1573 Vice Lane (U137)	2731 1645 Footpath 3	<u>From Road U.137, west of Porter's Farm, to junction with No. 3</u> From U.137, over stile, northeastwards along 3 ft. wide grass headland of arable field, over stile, northwards along undefined path across pasture, through gap, along verge of pasture on east side of hedge, over plank bridge, over stile, and along path through copse to junction with No. 3.	
<b>Bramshaw 6</b>	Footpath	2791 1571 Road C17	2843 1494 Parish Boundary	<u>From Road C.17, west of Norwood Copse, to Parish Boundary</u> From C.17, over stile, southeastwards along gravel road 12 ft. wide through trees, through gap, along road enclosed between bushes and wire fence, along road enclosed 10 ft. wide between banks, along road 8 ft. wide enclosed 20 ft. to 30 ft. between wire fences, and through wicket gate at swing gate to Parish Boundary.	
<b>Bramshaw 7</b>	Footpath	2635 1540 Road C17	2601 1582 Bramble Hill Hotel	<u>From Road C.17, west of Bramshaw Village, to Bramble Hill Walk</u> From C.17, northwestwards along unenclosed gravel road approx. 9 ft. wide across gorse, through wicket gate, at lodge gate, along road enclosed between bushes, westwards along unenclosed road on northeast side of wire fence, northwestwards along road 8 ft. wide enclosed between wire fence and hedge, southeastwards past outbuilding and along road between iron fences, northwards along road between bushes and cottage, northwestwards along path between cottage and garage, and then through field gate to Bramble Hill Walk.	
<b>Bramshaw 8</b>	Footpath	2705 1508 Road B3079	2730 1509 Road U137	<u>From Road B.3079, east of Burnford House, to junction with Road U.137</u> From B.3079, over earth culvert and stile, eastwards along unenclosed grass path between hedge and trees, along path between fir plantation and wire fence, along path enclosed 12 ft. to 8 ft. wide between wire fence and iron fence, and over stile at wicket gate to junction with U.137	

<b>Bramshaw 9</b>	Restricted Byway	2781 1448 Road U137	2743 1406 Road B3079	<u>From Road U.137, southwest of Warren's Farm, to junction with Road B.3079</u> From U.137, southwestwards along gravel road 12 ft. wide through trees, through gap, along road enclosed between bushes and wire fence, along road enclosed 10 ft. wide between earth banks, along road 8 ft. wide enclosed 20 ft. to 30 ft. wide between wire fences, and through gate to junction with B.3079.	
<b>Bramshaw 10</b>	Footpath	2315 1401 Road U137 opposite church	2369 1391 Road U137 at Fritham	<u>From Road U.137, south of Royal Oak Inn, Fritham, to junction with Road U.137</u> From U.137 opposite U.F. Church southwards along unenclosed gravel road 12 ft. wide between fence and woods, along road 8 ft. wide between hedge and common, over stile at swing gate, along earth track enclosed 12 ft. wide between hedges, over stile at field gate, along verge of pasture on north side of hedge, over earth culvert, along verge of pasture, over stile, along verge of pasture southeast of hedge, over stile, along undefined path across pasture, and through iron kissing gate to junction with U.137.	
<b>Bramshaw 790</b>	Restricted Byway	2275 1457 Eyeworth Pond	2281 1668 Road B3078	<u>From Road B.3078 to Road U.137 at Eyeworth Lodge</u> From Road B.3078 southwards along unenclosed roughly metalled track approx. 8 ft. wide, across open Forest land to Road U.137 at Eyeworth Lodge.
