That part of the path which, as a result of the diversion, runs between 8058 5095 and 8040 5107 has not been added to the Definitive Map because it is a footway at the side of a public road.</p>

Ewshot 744	Bridleway	8166 4998 Church Lane	8206 4967 Beacon Hill Road	<u>From Road C.156 at Ewshott to Road B.3013</u> From Windmill Inn, Ewshott, south eastwards along gravel lane 12 ft. wide enclosed between hedges, then along track through woods enclosed 10 ft. wide between wire fences on to Road B.3013.	
Ewshot 745	Footpath	8119 4933 Redlands Lane	8119 4946 Road A287	<u>From Road U.247 (Redlands Lane) to Road A.287</u> From U.247 northwards along earth path through woods enclosed 1.83 metres wide between wire fences and on to Road A.287.
