Kilmeston 4	Footpath	5887 2593 Road C149, Kilmeston Down Lane, west of The Old Posthouse	5817 2601 Beauworth 2, at Parish Boundary in West Wood	<u>From Road C.149 to Parish Boundary at West Wood</u> From C.149 over stile, westwards along verge of pasture, through hunting gate, then along earth track unenclosed through West Wood, and over slip rails at Parish Boundary.
Kilmeston 5	Footpath	5901 2635 Road C149, Kilmeston Road, south of Blackthorn Nursery	5829 2632 Beauworth 1, at Parish Boundary in West Wood	<u>From Road C.149 to Parish Boundary at West Wood</u> From C.149 westwards along 10ft. wide earth track enclosed between hedges to Parish Boundary.
Kilmeston 6	Footpath	5921 2565 Road U178, Down Lane, north-east of Stanmore House	5941 2565 Footpath 8	<u>From Road U.178 to Junction with No. 7</u> From U.178 over hedge and wire fence, then eastwards along verge of arable field, over double wire fence and through field gate at junction with No. 7.

Kilmeston 8	Footpath	5957 2635 Road U178, Church Road, east of St. Andrew's House	5929 2583 Road U178, Down Lane, west of Dean Farm	<u>From Road U.178 east of Vicarage to Road U.178 at Pond</u> From U.178 eastwards along grass track, then through gap and southwards along verge of arable field to old chalk pits, then through field gate and southwards across pasture over two wire fences, and across pasture, then westwards along grass track enclosed between hedges, turning north westwards to junction with U.178 at Kilmeston Pond.
Kilmeston 9	Footpath	5921 2637 Road C149, Kilmeston Road, east of Kilmeston Manor	5969 2720 Restricted Byway 11, and with Bramdean 4, at Parish Boundary	<u>From Road C.149 at St. Andrew's Church to Road U.178 (unmetalled)</u> From C.149 over stile and north eastwards across pasture, over stile, across pasture, then along chalk track across pasture and through hunting gate into unmetalled lane U.178.

That part of the path which ran between 5941 2564 and 5990 2513 has been diverted and now runs between 5966 2562 and 5990 2513

Kilmeston 11	Restricted Byway	5895 2729 Road C149, Kilmeston Road, south of Source of the Itchen	5969 2720 Footpath 9	<p><u>From Road U.169 to junction with No. 9 at Parish Boundary</u></p> <p>From Road C.149 eastwards along grass track approximately seven feet wide between hedges approximately twenty eight feet apart, then between fences to junction with No. 9 at Parish Boundary.</p>
