<b>Linkenholt 1</b>	Footpath	3653 5786 Road C33	3742 5783 Faccombe 9 at parish boundary	<u>From C.33 at Lower Farm to Parish Boundary</u> From C.33 eastwards along earth track, through field gate then along verge of pasture on south side of fence, over stile along grass path enclosed 4 ft. wide between trees and wire fence to rails at Parish Boundary.
<b>Linkenholt 2</b>	Bridleway	3717 5859 Road C33	3562 5910 County Boundary	<u>From C.33 to County Boundary at Linkenholt Hanging</u> From C.33 through double gate and westwards along metalled track approx. 8 ft. wide to Bottom Barn, then northwards along track enclosed between fences to pump house and along grass track enclosed between wire fence and Linkenholt Hanging to field gate at County Boundary.
<b>Linkenholt 3</b>	Footpath	3641 5861 Bridleway 2	3612 5815 Parish Boundary at Manor House	<u>From No. 2 at Bottom Barn to C. 109 at Manor House</u> From No. 2, southwestwards along earth track up hillside then along earth track enclosed approx. 12 ft. wide to Manor House then along grass track enclosed approx. 30 ft. wide between trees and hedge and along metalled track on to C.109.
<b>Linkenholt 4</b>	Footpath	3685 5694 Junction of Restricted Byway 7 and Road U58	3666 5661 Vernhams Dean 1 at parish boundary	<u>From U.58 southwest of Rymer's Barn to Parish Boundary</u> From U.58, through gap and southwestwards across arable field to Parish Boundary.
<b>Linkenholt 5</b>	Footpath	3728 5712 Road U58	3735 5713 Faccombe 4 at parish boundary	<u>From U.58, east of Rymer's Barn to Parish Boundary</u> From U.58 eastwards along earth track enclosed approx. 7 ft. wide to Parish Boundary.
<b>Linkenholt 6</b>	Restricted Byway	3802 5941 County Boundary	3721 5868 Road C33	<u>From Parish Boundary to Road C.33</u> From Parish Boundary southwestwards along grass track 10 ft. wide between bushes, then between fence approx. 60 ft. apart, then roughly metalled 8 ft. wide between arable field and fence approx. 60 ft. apart and on to Road C.33.
<b>Linkenholt 7</b>	Restricted Byway	3685 5694 Junction of Road U58 and Footpath 4	3697 5655 Hurstbourne Tarrant 25 at parish boundary	<u>From Road U.58, at junction with No. 4, to Parish Boundary.</u> From Road U.58, at junction with No. 4, southeastwards along roughly metalled track 9 ft. wide between hedge and arable field approx. 25 ft. apart, then southwards along roughly metalled track between fence and hedge approx. 25 ft. apart to Parish Boundary.
