<b>Lyndhurst 2</b>	Footpath	2941 0898 Road U139 at Pikes Hill	2941 0889 Road U139 at Pikes Hill	<u>From Road U.139, north of Northerwood Farm, to junction with Road U.139</u>  From U.139, through kissing gate, southwards along asphalt path enclosed 6 ft. wide between fences, and through gap to junction with U.139.
<b>Lyndhurst 3</b>	Footpath	2963 0886 Road U139 at Pikes Hill	2953 0895 Road U139 at Pikes Hill	<u>From Road U.139, to junction with Road U.139, west of Northerwood Farm.</u>  From U.139, northeastwards along metalled road enclosed 20 ft. wide between fences, northwestwards along road 9 ft. wide enclosed 50 ft. to 20 ft. wide between houses, fences and hedge, along earth track 8 ft. wide enclosed 20 ft. to 30 ft. between fence and hedge, then southwestwards along verge of green on northwest side of fence to junction with U.139.
<b>Lyndhurst 4</b>	Footpath	2972 0874 Road U139 at Pikes Hill	2951 0867 Tuning space off Pikes Hill Avenue	<u>From Road U.139, west of Holly Mount, to turning point in Road U.139 off Pikes Hill Avenue</u>  From Road U.139 westwards along gravel path enclosed 8 ft. wide between fences, through kissing gate, along gravel path 4 ft. wide, enclosed 10 ft. wide between fences, and through kissing gate into turning point in Road U.139.
<b>Lyndhurst 5</b>	Bridleway	3185 0737 Road B3056 north-east of Parkhill Lodge	3142 0684 Edge of Forest	<u>Road U.139 northeast of Parkhill House to Open Forest</u>  From U.139 over bridge, southwestwards along earth track enclosed approx. 10 ft. wide between hedge and fence, then along unenclosed grass track west of Pondhead to timber bridge across Matley stream. Part of this path lies within the open Forest, part within the boundary of Parkhill.
<b>Lyndhurst 6</b>	Footpath	2975 0870 Road U139 at Pikes Hill	2988 0846 Romsey Road	<u>From Road U.139, opposite Holly Mount, to junction with Road A.337</u>  From U.139, southeastwards along gravel path 5 ft. wide on verge of green on northeast side of hedge, along gravel path 3 ft. wide on northeast side of wire fence, along path enclosed 35 ft. to 25 ft. wide between fences, along path 5 ft. wide across green on northeast side of fence, along path 10 ft. to 15 ft. wide between fences, and then along unenclosed path across green verge to junction with A.337.
<b>Lyndhurst 501</b>	Footpath	3008 0827 Wellands Road	3009 0820 High Street (A35)	From Wellands Road at bend, on 1.8 m wide mainly tarmac path south-southeast for 34m to pass through staggered barrier. Continues south-southeast for 50m across concrete, tarmac and paving part of garage premises, passing east of petrol pumps to reach A35 Lyndhurst High Street.
