Mottisfont 12	Footpath	3041 2718 Lockerley 12 at Parish Boundary	3162 2692 Romsey Road (B3084)	<u>From Road B.3084 to Parish Boundary</u> From Road B.3084 westwards along approx. 10 ft. wide gravelled lane narrowing to 8 ft. wide track, through field gate, along verge of pasture on south side of hedge, over post and rail fence, along verge of pasture on south side of hedge, over post and rail fence, along verge of pasture, across footbridge, along verge of pasture on south side of wire fence, crossing No.14, over stile, along grass path on north side of fir plantation, across ditch, then northwestwards along 8 ft. wide ride through woodland, over ditch, along ride, over ditch, and along ride to post and rail fence at Parish Boundary.
