Rooksdown 707	Footpath	6131 5416 Rooksdown Lane (U264)	6140 5440 Sherborne St John 7 at parish boundary	<p><u>From Road C.144 opposite Park Prewett to junction with No. 3 at Chalk Pit</u></p> <p>From C.144 through gap, northeastwards along 4 ft. wide earth path enclosed between fences, then along verge of pasture, over stile and along 10 ft. wide farm track to junction with No. 3.</p> <p>Shown on Sherborne St. John Award Map dated 1830 as a 4 ft. wide footway.</p>
