Shalden 2	Footpath	6955 4192 Footpath 10	6969 4203 Road U227	<u>From Road U.227, opposite School House to No. 10</u> From Road U.227 southwestwards over stile, along 10 ft. wide path enclosed between fences, over stile, and across pasture to junction with No. 10.
Shalden 3	Footpath	6849 4107 Road A339	6938 4172 Road C224	<u>From Road C.224 at St. Peter and St. Paul's Church to Road A.339 at the Parish Boundary</u> From C.224 southwestwards along grass path enclosed 10 ft. wide between hedges, through wicket gate, along gravel path to church then across churchyard, over stile, across pasture, over stile, across paddock, over stile, along headland of arable field, over slip rails, along verge of pasture to southeast corner of plantation, then across pasture, through iron field gate, across arable field, over stile, down steps, across railway, up steps, over stile and along earth path unenclosed through woods to junction with Road A.339.
Shalden 4	Footpath	6869 4190 Lasham 1 at Parish Boundary	6924 4187 Road C224	<u>From Road C.224 to the Parish Boundary</u> From C.224 through field gate, westwards across pasture, over wire fence, across arable field, through gap and across pasture to tree belt at the Parish Boundary.
Shalden 5	Footpath	6907 4363 Parish Boundary at Lasham Corner	6966 4229 Road C224	<u>From Road C.224 to Lasham Corner</u> From C.224 over stile, northwestwards along earth path unenclosed through copse, over rails, along verge of pasture, over stile, along verge of arable field, through wicket gate, along earth path unenclosed through wood, along earth track, then along 9 ft. wide concrete road to the Parish Boundary.
Shalden 6	Footpath	6978 4273 Road C224	7073 4330 Avenue Road	<u>From Road C.70 at the Golden Pot to Road C.224</u> From C.70 through gate, southwestwards along earth path unenclosed through wood, over stile, across pasture, over stile, across arable field, over stile, across pasture, over rails, then along sunken track on verge of pasture, over stile, and along earth path through copse on to Road C.224.

That part of the path which ran between 7073 4326 and 7079 4329 has been diverted and now runs between 7073 4326 and 7073 4330

Shalden 8	Footpath	7081 4220 New Odiham Road (B3349)	7112 4236 BOAT 12	<u>From Road C.32 at Gregory's Wood to No. 12</u> From A.32, through gateway, eastwards along grass path enclosed 6 ft. wide between wire fence and hedge, then across Golf Course to junction with Road U.227 (unmetalled) at old chalk pit.
Shalden 9	Footpath	7146 4242 BOAT 13	7195 4155 Footpath 14 at Parish Boundary	<u>From Parish Boundary near Anstey Copse to No. 13</u> From Row Wood northwards along grass path enclosed approximately 4 ft. wide between wood and fence, through squeeze stile, and northwards along verge of pasture, skirting Row Wood, through squeeze stile, along earth path inside wood, through gap, along verge of pasture, over stile, along verge of arable field, through gap, along verge of pasture, over stile, along verge of arable field, over stile, along verge of pasture, over stile, along verge of pasture, over stile and wire fence, then northwards inside road, through gap, along verge of pasture and through wicket gate on to Road U.229, (unmetalled).
Shalden 10	Footpath	6952 4192 Road C224	6980 4159 Footpath 1	<u>From Road C.224 at Manor Farm to junction with No. 1</u> From C.224 over stile, southeastwards along earth track, over stile, across pasture, through field gate and along verge of arable field to junction with No. 1.
Shalden 11	Byway Open to All Traffic	6974 4202 Road U227	7078 4246 New Odiham Road (B3349)	<u>From Road U.227 at Shalden to Road A.32</u> From U.227 northeastwards along earth track enclosed approximately 10 ft. wide between hedges, then along earth track unenclosed through Shalden Park Wood to Road A.32.
Shalden 12	Byway Open to All Traffic	7079 4246 New Odiham Road (B3349)	7126 4238 Road C124	<u>From Road A.32 at Shalden Park Cottages to Road C.124</u> From A.32 southeastwards along earth track, through tree belt, then southwards, and eastwards, along sunken earth track enclosed between banks and hedges to Road C.124.
Shalden 13	Byway Open to All Traffic	7131 4230 Road C124	7147 4242 Froyle 34 at Parish Boundary	<u>From Road C.124 to the Parish Boundary</u> From C.124 eastwards and northeastwards along earth track enclosed approximately 15 ft. wide between hedges then widening to 30 ft. between hedges to the Parish Boundary.
Shalden 14	Footpath	7180 4143 Road U229	7195 4156 Footpath 9 at Parish Boundary	<u>From Road U.229 at Anstey Copse to junction with No. 9</u> From U.229 northeastwards along verge of pasture, skirting Anstey Copse, then along unenclosed path across pasture to junction with No. 9 at stile on Parish Boundary.
