Stratfield Saye 6	Footpath	6610 6125 Footpath 1	6580 6147 Silchester 20 at Parish Boundary	<u>From No. 1 south of Lovell's Farm to Parish Boundary</u> From Path No. 1 northwestwards along headland of arable field to wire fence at Parish Boundary.
Stratfield Saye 7	Footpath	6666 6177 Mortimer Lane	6612 6215 Mortimer West End 30 and Silchester 19 at Parish Boundary	<u>From Road C.80 at Dollery's Farm to Parish Boundary</u> From C.80 through gate, along southeast verge of pasture then northwestwards along verge of pasture, through hedge, over stile, and through hedge, along headland of arable field, then along undefined path to hedge and wire fence at Parish Boundary.
