Stratfield Turgis 2	Footpath	6964 5939 Reading Road (A33)	6905 5971 Footpath 4	<u>From Road A.33 to junction with No. 4</u> From A.33 over bar fence, northwestwards across grassland, over wire fence, across arable field, through gap, along verge of arable field, over bar fence, then along grass path unenclosed between arable fields, and along headland of arable field, then along unenclosed path between arable fields to junction with No. 4.
Stratfield Turgis 3	Footpath	6947 5912 Reading Road (A33)	6891 5944 Footpath 4	<u>From Road A.33 to junction with No. 4</u> From A.33 through field gate, along verge of arable field, through gap, along verge of arable field, then along grass path unenclosed between arable fields, to junction with No. 4.
Stratfield Turgis 4	Footpath	6914 5995 Turgis Court Road (U262)	6870 5905 Footpath 7	<u>From Road U.262 east of Turgis Court to junction with No. 7 at Newhouse Farm</u> From U.262 southwestwards along earth track on headland of arable fields to junction with No. 3, then along grass path unenclosed between arable fields, over wire fence, along verge of pasture, over wire fence, along verge of pasture and through field gate at junction with No. 7.
Stratfield Turgis 5	Footpath	6910 5987 Footpath 4	6896 5999 Footpath 6	<u>From No. 4 to No. 6 at Turgis Court</u> From No. 4 over wire fence, northwestwards across pasture, and along verge of pasture, over bar fence, then northeastwards along grass track and through field gate at junction with No. 6.
Stratfield Turgis 6	Footpath	6900 6004 Bridleway 9 at Turgis Court Farm	6883 6009 Stratfield Saye 501 at Parish Boundary	<u>From Road U.262 at Turgis Court to Parish Boundary</u> From U.262 southwestwards along gravel farm road, through field gate across paddock, over 10 ft. wide cattle bridge, across pasture, and over 3 ft. wide footbridge at the Parish Boundary.

That part of the path which ran between 6895 6001 and 6870 5996 has been diverted and now runs between 6895 6001 and 6883 6009
Minimum 1.8 metres wide between 6895 6001 and 6883 6009

Stratfield Turgis 7	Footpath	6885 5893 Reading Road (A33)	6768 5923 Bramley 11 at Parish Boundary	<u>From Road A.33 to Parish Boundary east of Lillymill Farm</u> From A.33 northwestwards along 10 ft. wide gravel road, enclosed approximately 15 ft. wide between hedges to "The Fishery" then southwestwards along grass track, through field gate, along grass track enclosed 10 ft. wide between hedges, through gateway (wired), then across pasture, over cattle bridge, across pasture, through field gate, and along verge of pasture, to the Parish Boundary.
Stratfield Turgis 8	Footpath	6766 5910 Bramley 12 at Parish Boundary	6781 5890 Hartley Wespall 1 at Parish Boundary	<u>From Parish Boundary east of Lillymill Farm to Parish Boundary</u> From Parish Boundary southeastwards along farm track unenclosed across pasture, then southwards along verge of pasture, through field gate, along earth track on headland of arable field and through field gate at Parish Boundary.
Stratfield Turgis 9	Bridleway	6901 6005 Road U252 and Footpath 6 at Turgis Court Farm	6932 6099 Green Lane (C80)	<u>From Road U.262 at Turgis Court to Road C.80</u> From U.262 northeastwards along gravel track, through field gate, then along grass track enclosed approximately 20 ft. wide between hedge and river bank, through field gate, along grass track, through gateway, along grass track, through field gate, across pasture and through field gate on to Road C.80.
Stratfield Turgis 10	Footpath	6920 5898 Reading Road (A33) at Spanish Green	6826 5893 Hartley Wespall 20 at Parish Boundary	<u>From Road A.33 to Parish Boundary</u> From A.33 through gateway, southeastwards across grass enclosure, through gate, across chicken run, through gate, along earth track, and over stile at Parish Boundary.
