Sway 1	Footpath	SZ 2824 9818 Birchy Hill	SZ 2862 9809 Coombe Lane	<u>From Road B.3055, north of Birchy Hill to Road U.146</u> From B.3053, through field gate, southeastwards along gravel road 7 ft. to 10 ft. wide, enclosed between fence and hedge, along grass path between trees and fence/brick wall, over slip rail, along path enclosed 8 ft. to 14 ft. wide between hedge and brick wall, along 14 ft. wide grass headland of arable field on south side of hedge, and then along path through copse, over stile and plank bridge, along undefined path across pasture, through gap and over earth culvert, then northeastwards along undefined path across pasture, and through field gate to junction with U.146 at North Sway Farm.
Sway 2	Footpath	SZ 2881 9840 Chapel Lane	SZ 2932 9823 Pitmore Lane	<u>From Road U.146 near Baptist Chapel to junction with Road C.75</u> From U.146, over stile, southeastwards along verge of pasture on northeast side of wire fence, over twin stiles, along undefined path down grass cattle drove enclosed 20 ft. to 30 ft. wide between hedges, over slip rails, along grass track approx. 8 ft. wide enclosed between wire fence and hedge, over stile, and along earth path enclosed 20 ft. to 15 ft. wide between hedges to junction with C.75.
Sway 3	Footpath	SZ 3033 9749 Road U146 at Mount Pleasant Farm	SZ 3036 9798 Forest Edge	<u>From Road U.146, southeast of Mount Pleasant to Forest Boundary</u> From Road U.146, northwards along gravel road 7 ft. wide, enclosed 11 ft. wide between brick wall and wire fence, along grass path enclosed 5 ft. wide between wire fence and hedge, over stile, northeastwards along undefined path across pasture, over stile at field gate, northwards along undefined path across pasture, over stile and plank footbridge, along grass path enclosed 6 ft. wide between wire fences, along path between brick wall and wire fences, along path between brick wall and wire fence, and over stile to junction with track on Forest boundary. Part of the footpath shown on the Sway and Arnewood Inclosure Award dated 1820.
Sway 4	Footpath	SZ 2795 9642 Barrows Lane	SZ 2778 9609 Hordle 741 at Parish Boundary	<u>From Road U.146, west of Barrows Copse, to Parish Boundary</u> From U.146, through gap, south westwards along unenclosed earth path 6 ft. wide between copse and iron fence, along path enclosed 8 ft. wide between wire fence and iron fence, over stile southwards along verge of pasture on east side of wire fence, through gap, along undefined path across pasture, over twin stiles, south westwards along verge of pasture on south east side of hedge, and then southwards along verge of pasture to Parish Boundary.
Sway 6	Footpath	SZ 3034 9746 Road U146 south-east of Mount Pleasant	SZ 3033 9685 Lymington and Pennington 62 at Parish Boundary	<u>From Road U.146, southeast of Mount Pleasant to Parish Boundary</u> From U.146, southwestwards along grass track enclosed 8 ft. to 20 ft. wide between hedges, along unenclosed path through copse, along undefined path known as The Serpentine (the original path now obliterated by gravel workings, its reinstatement being a condition of planning consent), along undefined path across pasture and southeastwards along grass path enclosed 5 ft. wide between wire fence and hedge, and along path through trees to Parish Boundary.
Sway 7	Footpath	SZ 3020 9735 Footpath 6	SZ 3012 9750 Road U146	<u>From No.6 to junction with Road U.146</u> From No. 6 over stile, northwestwards along undefined path across gravel workings, and over stile to junction with U.146.

Sway 8	Footpath	SZ 2876 9661 Footpath 9	SZ 2840 9610 Hordle 742	<u>From No.9 at Flexfordbridge Farm to Parish Boundary</u> From No.9, southwestwards along grass track enclosed approx.12 ft. between hedges, over stile, along 4 ft. wide grass headland of arable field on northwest side of hedge, over plank bridge and stile, along undefined path of pasture on south side of stream, south across pasture, over stile, across pasture, through gap, across pasture and through gap to Parish Boundary.	
Sway 9	Byway Open to All Traffic	SZ 2879 9672 Road U146 at Flexford Bridge	SZ 2888 9633 Hordle BOAT 743	<u>From Road U.146, at Flexford Bridge, to Parish Boundary</u> From U.146 southwestwards along gravel road 7 ft. wide enclosed 25 ft. to 22 ft. wide between hedges, along earth track 7 ft. wide between farm building and hedge, through field gate, southwards along track enclosed approx. 26 ft. wide between hedges, over plank and earth culvert, and along track enclosed 20 ft. between hedges to Parish Boundary.	
Sway 10	Bridleway	SZ 2712 9895 Adlam's Lane north-west of Sway Station	SZ 2689 9918 Edge of Forest	<u>From Road U146, north-west of Sway Station to Forest Boundary</u> From U.146 northwestwards along grass track enclosed approx.25 ft. wide between hedges, over earth culvert, along unenclosed track across pasture, and through swing gate to Forest boundary.	
Sway 11	Footpath	SZ 2653 9740 Crabbwood Lane	SZ 2611 9724 Hordle 766 at Parish Boundary	<u>From Road U.146, opposite to Crabb's Copse, to Parish Boundary</u> From U.146, over stone and earth culvert, through gate, westwards along gravel road enclosed approx. 10 ft. wide between wire fence and hedge, along grass track enclosed 12 ft. wide between hedge and wire fence, over stile, at slip rails, along verge of pasture on south side of hedge, over stile, along verge of pasture, over stile, along earth path enclosed 5 ft. wide between hedges, through kissing gate, along gravel road 7 ft. wide, enclosed 12 ft. wide between hedge and out-buildings, through swing gate, and along road enclosed approx. 16 ft. wide between hedges to Parish Boundary.	
Sway 12	Footpath	SZ 2664 9713 Road B 3055 west of Arnewood Manor Farm	SZ 2637 9668 Hordle 747 at Parish Boundary	<u>From Road B.3055, west of Arnewood Manor Farm, to Parish Boundary</u> From B.3055, over stile at field gate, southwestwards along grass track enclosed 10 ft. wide between fences, over stile, at field gate, along verge of pasture on southeast side of wire fence, over stile, along verge of pasture on southeast side of wire fence over stile, and along verge of pasture to Parish Boundary.	
Sway 13	Bridleway	SZ 2861 9932 North-west of railway line at Widden Bottom	SZ 2865 9929 South-east of railway line at Widden Bottom	<u>From Widden Bottom to open Forest</u> From Widden Bottom northwestwards along 12 ft. wide track across brick bridge over railway to open Forest.	
Sway 14	Bridleway	SZ 2836 9884 Road B3055	SZ 2827 9899 Forest Edge	<u>From Road B.3055 to open Forest</u> From Road B.3055 northwestwards along 12 ft. wide track across brick bridge over railway to open Forest.	
Sway 15	Byway Open to All Traffic	SZ 2758 9607 Hordle 7107	SZ 2737 9722 Arnewood Bridge Road	<u>From Parish Boundary to Road B.3055, at Arnewood</u> From Parish Boundary at junction with accommodation road leading to Road C.430 northwards to entrance to pig farm, then northwards along earth track between hedges, through ford and along track, then turning westwards along earth track approx. 15 ft. wide, across Road U.146, then along enclosed grass track to junction with Road B.3055.	

Sway 16	Byway Open to All Traffic	SZ 2869 9699 South Sway Lane	SZ 2955 9735 Pitmore Lane	<u>From Road C.75, at Flexford Mill, to Road C.76, Pillmore Lane</u> From Road C.75 eastwards along earth track approx. 6 ft. wide between banks, then along grass and gravel track to Road C.75.
