That part of the path which ran between 2975 4575 and 2974 4580 has been extinguished
<b>Thrupton 2</b>	Restricted Byway	2711 4539 Road U57	2698 4567 Kimpton 13 at Parish Boundary	<u>From Road U.57, southeast of Thrupton Copse to Parish Boundary</u> From Road U.57, northwestwards along track (approx. 7 ft. wide) enclosed 12 ft. – 20 ft. wide between trees and wire fence, and along track between copse and wire fence to Parish Boundary.	
<b>Thrupton 3</b>	Footpath	2906 4587 Stanbury Close	2935 4613 Fyfield 3 at Parish Boundary	<u>From Road C.17, north of Thrupton Rectory to Parish Boundary</u> From Road C.17, northeastwards along earth cart track enclosed approx. 10 ft. wide between wire fences, along grass track enclosed approx. 10 ft. wide between wire fence and hedge, through angled barrier, along verge of pasture on northwest side of wire fence, through slip rails, along verge of pasture on northwest side of wire fence and over wire fence at Parish Boundary.	That part of the path which ran between 2907 4586 and 2900 4579 has been diverted and now runs between 2906 4586 and 2899 4583 That part of the path which, as a result of the diversion, runs between 2906 4587 and 2899 4584 is not shown on the Definitive Map as it is a highway at the side of a public road 1.83 metres wide between 2906 4587 and 2907 4586

That part of the path which ran between 2927 4548 and 2925 4551 has been extinguished
<b>Thrupton 5</b>	Footpath	2986 4628 Fyfield 1 at Parish Boundary	3003 4606 Amesbury Road at Parish Boundary	<u>From Parish Boundary, northwest of Eastfield House to Road A.303</u> From rails at Parish Boundary through trees, southeastwards along 3 ft. wide grass headland of arable field on southwest side of wire fence, and over stile to A.303.	
<b>Thrupton 6</b>	Footpath	2543 4421 Topliss Hill	2566 4395 Amport 23 at Parish Boundary	<u>From Parish Boundary at Middlecot to Road A.303 west of Thrupton Down House</u> From Parish Boundary, northwards along metalled track enclosed between fences to Road A.303.	That part of the path which ran between 2563 4423 and 2560 4435 has been diverted and now runs between 2563 4423 and 2543 4421
<b>Thrupton 7</b>	Footpath	2686 4456 Amport 24b at Parish Boundary	2685 4458 Road C131	<u>From Parish Boundary, northeast of Thrupton Down House to Road A.303</u> From Parish Boundary northwards, along path through trees, and through gap into Road A.303.	
<b>Thrupton 501</b>	Footpath	2906 4564 Stanbury Road	2916 4567 Lambourne Way	3.5 metres wide between 2906 4564 and 2910 4565; 3 metres wide between 2910 4565 and 2910 4564; 1 metre wide between 2910 4564 and 2914 4566; 2 metres wide between 2914 4566 and 2916 4567
