<b>Weston Corbett 1</b>	Bridleway	6820 4775 Weston Corbett (U260)	6843 4820 Upton Grey 21 at Parish Boundary	<u>From Road U.260 to Parish Boundary</u> From U.260 northeastwards along earth track enclosed approximately 10 ft. wide between wire fence and hedge, then along headland of arable field and through gap at Parish Boundary. Width varies between 2 and 4 metres as shown on the 1st edition Ordnance Survey 1:2500 plan of 1871.
<b>Weston Corbett 2</b>	Footpath	6823 4744 Weston Corbett (U260)	6860 4715 Road U260	<u>From Road U.260 at Reeds Farm to Road U.260</u> From U.260 northeast along 8 ft. wide gravelled road, over stile, then southeast over two stiles, along verge of arable field, over stile and along metalled track to Road U.260.
<b>Weston Corbett 3</b>	Footpath	6880 4708 Road U260	6896 4706 Weston Road (C12)	<u>From Road U.260 at Weston House to Road C.12 at Parish Boundary</u> From U.260 over stile, northeastwards across paddock over stile, then along verge of pasture and over stile on to Road C.12 at Parish Boundary.
<b>Weston Corbett 4</b>	Bridleway	6824 4719 Road U260	6800 4746 Tunworth 5 at Parish Boundary	<u>From Road U.260 to Parish Boundary</u> From U.260 northwestwards along earth track approximately 9 ft. wide enclosed between banks and hedges to the Parish Boundary.
<b>Weston Corbett 5</b>	Byway Open to All Traffic	6838 4700 Road U260	6857 4648 Weston Road (C12) Case Is Altered	<u>From Road U.260 to Road C.12 at Parish Boundary</u> From U.260 southeastwards along grass track 10 ft. wide, enclosed approximately 15 ft. wide between hedges, through field gate, and along grass track to Road C.12 at Parish Boundary.
